Hand Delivered bids will be received at the Oklahoma Department of Transportation Building, Facilities Management Division, 200 N.E. 21st Street, Room 1-B7, Oklahoma City, Oklahoma 73105 on July 16, 2020 until 1:30 PM. The bids will be opened and immediately read publicly on July 16, 2020 at 1:30 PM. in the ODOT Project Management Conference Room located at the address above.

Description of Property:

A strip, piece or parcel of land laying in the E/2 SW/4 of Section 30, T11N, R4W in Oklahoma County, Oklahoma. Said parcel of land being described by metes and bounds as follows:

Commencing at the SE corner of Said E/2 SW/4, thence S89°45'02"W along the South line of said E/2 SW/4 a distance of 670.54 feet to the **POINT OF BEGINNING**, thence continuing S89°45'02"W along said south line a distance of 563.80 feet, thence Northeasterly on a curve to the left having a chord bearing of N66°26'55"E and having a radius of 1991.88 feet an arc distance of 471.86 feet, thence Southeasterly on a curve to the right having a chord bearing of S78°14'14"E and having a radius of 68.24 feet an arc distance of 84.81 feet, thence S43°45'21"E a distance of 19.13 feet, thence Southerly on a curve to the left having chord bearing of S46°32'07"E and having a radius of 761.15 feet an arc distance of 73.85 feet, thence Southerly on a curve to the right having a chord bearing of S07°57'57"E and having a radius of 39.37 feet an arc distance of 45.07 feet, thence Southwesterly on a curve to the left having a chord bearing of S22°38'37"W and having a radius of 232.94 feet an arc distance of 64.54 feet to said **POINT OF BEGINNING**.

Containing 1.39 acres, more or less, inclusive of the 33 feet of statutory section line right of way being located along the South side of the above described property.
