APPROVAL OF MINUTES

LEGISLATIVE UPDATE – Secretary Tim Gatz

STATE

HB3171 - Drone Privacy Act (Representative Phillips and Senator Bergstrom) Signed by the Governor on May 24th. Takes effect on November 1st.

FEDERAL

Federal Aviation Administration confirmed that it will be modifying its regulatory approach for certification of powered-lift operations and the pilots that operate these aircraft. In the short-term, the FAA plans to use its "special class" process in 14 CFR 21.17(b) to type certificate powered-lift aircraft, in order to address the unique features of emerging powered-lift models.

These aircraft are different than traditional fixed wing and current rotorcraft/helicopters due to fuel type (all electric or hybrid) and multiple rotor designs.

Senate Committee on Commerce, Science, and Transportation approved the Advanced Aviation Infrastructure Modernization Act (S.4246), sending it on to the full Senate. The Advanced Aviation Infrastructure Modernization (AAIM) Act, introduced by Senators Alex Padilla (D-CA) and Jerry Moran (R-KS), authorizes a \$25 million grant program for state, local, tribal governments, transit agencies, port authorities, and metropolitan planning organizations to plan the infrastructure needed to support advanced air mobility (AAM) operations.

The House Transportation and Infrastructure Committee approved legislation (<u>H.R. 5315</u>) by 54-4 that would create an infrastructure inspection grant program to fund drones that could help find cracks in bridges. Lawmakers also backed a bill (<u>H.R. 6270</u>) in a 55-2 vote that would provide grants to develop advanced air mobility infrastructure—where flying taxis would be able to land, for example.
