ALL PROPOSALS NOT MAILED WILL BE TURNED INTO THE REPRODUCTION OFFICE IN THE MAIN LOBBY OF THE OKLAHOMA DEPARTMENT OF TRANSPORTATION BUILDING PRIOR TO THE OPENING OF THE DEPARTMENT OF TRANSPORTATION COMMISSION ROOM.

INSTRUCTIONS FOR USING THE ELECTRONIC BIDDING SYSTEM (EBS) ARE AVAILABLE FROM THE OFFICE ENGINEER'S OFFICE.

THE PRINTED BID SHEETS THAT ARE CREATED FROM THE EBS SYSTEM WILL BE PLACED IN FRONT OF THE BID ITEM PAGES IN THE BIDDING PROPOSAL AND WILL BE TURNED IN WITH THE BID DOCUMENTS ALONG WITH THE PROPER DISK. (THE PAPER COPY OF THE BID ITEMS IS THE OFFICIAL BID DOCUMENT.)

PLEASE PUT THE CALL ORDER NUMBER OF THE JOBS YOU ARE BIDDING ELECTRONICALLY ON THE DISK LABEL OF THE ORIGINAL DISK. BE SURE TO SAVE YOUR WORK AND ANY REVISIONS YOU RECEIVE TO YOUR ORIGINAL DISK AND SUBMIT THAT DISK WITH YOUR BID.
