Details: The district 1 work forces will stabilize the subgrade with Kiln Dust or Fly Ash material and prepare for paving so it will be ready for application. Asphalt Overlay is to begin at the intersection of Waterloo Rd. and County Line Rd. going west to the first bridge approach. Then west again from the other side of that bridge to the next bridge approach.


