CONTRACT ITEM 12 – CONCRETE TRAFFIC RAIL

Description: Under the Contract Item for Concrete Traffic Rail, the Contractor shall be responsible for furnishing all labor, materials, and equipment necessary for the installation of the concrete traffic rail as shown on the Construction Plans and in accordance with the 2009 Oklahoma Department of Transportation standard details and specifications. Concrete traffic rails include, but not limited to the following: concrete traffic rails and rail anchorage curbs. This item shall include all labor to construct concrete traffic rails to the specifications set forth by the construction plans, all equipment and labor required to off load and set materials, all materials required to construct the concrete traffic rails inclusive of required concrete, grout, rebar and all appurtenances to produce a finished product as specified and approved by the County and Engineer. The contractors shall provide all tools, gaskets, grout, concrete, rebar, labor, forms, form work, all specialty tools, all safety equipment, all quality control and all other items or work required to complete the construction of this item. This item shall also include all labor, concrete, reinforcement bars, reinforcement bar ties, concrete testing, forms and form work, all materials necessary for construction.

Payment: Payment for Concrete Traffic Rail shall be made at the Contract per foot Price for Contract Item 12.
