2. Late bids will not be considered. Bids must be received in sealed envelopes (one to an envelope) with bid number and closing date written on the outside of the envelope. Bids must be marked **“Asphalt Overlay District 1” Bid #19-01 & received in the County Clerk’s office at 317 E. Lee Room 100 Sapulpa, OK. 74066 by 8:59 am August 20, 2018.**
3. Unit prices will be guaranteed correct by the bidder. Items & services on this bid will be awarded separately to the lowest/best bidder as determined by the county. County reserves the right to accept or reject any or all bids. Successful bidders must verify workers’ compensation coverage & general liability of company & outsource. Successful vendors should invoice each district separately & show delivery locations.
4. Firm prices will be F.O.B. destination.
5. Purchases by **CREEK** County, Oklahoma, are not subject to state or federal taxes.

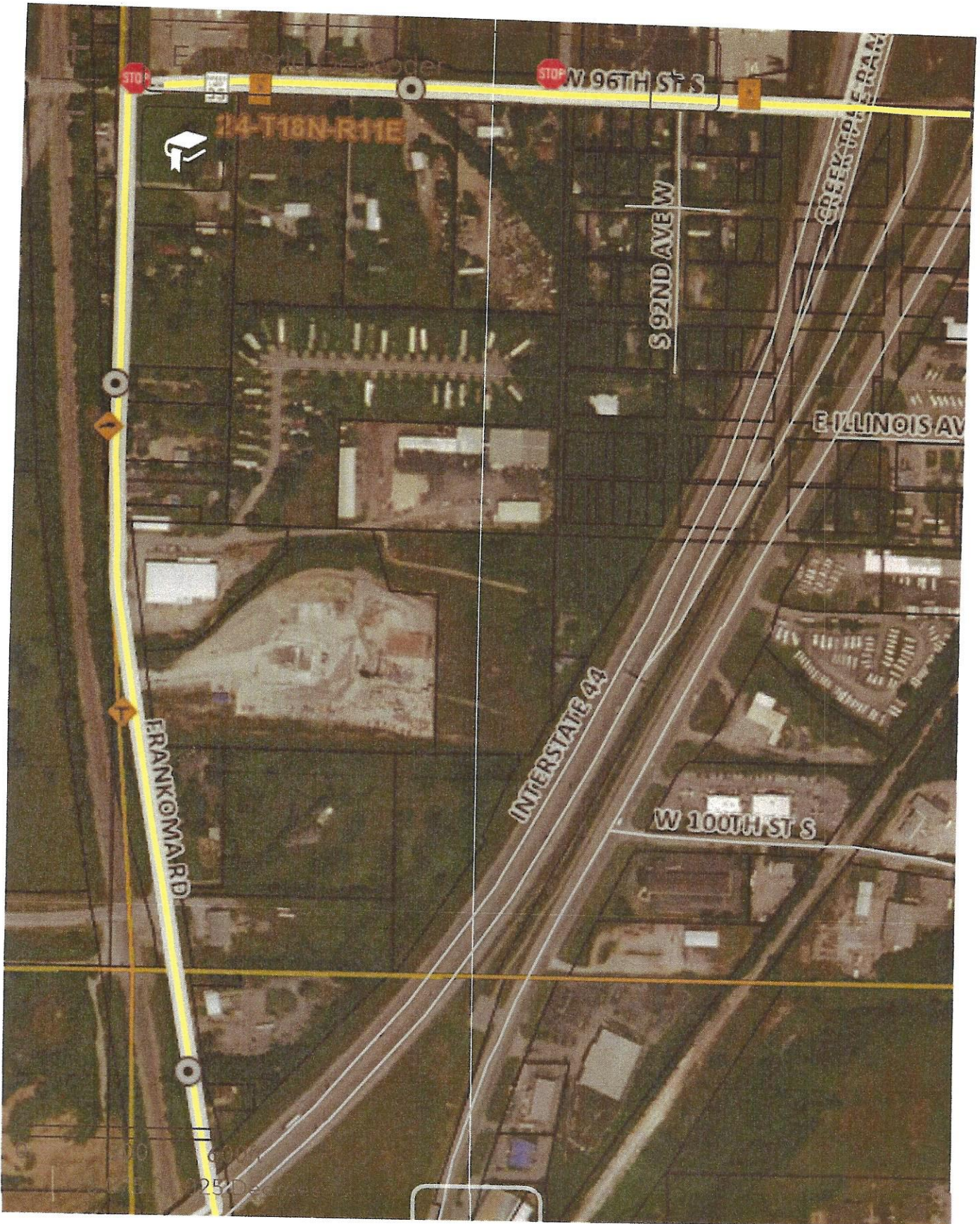

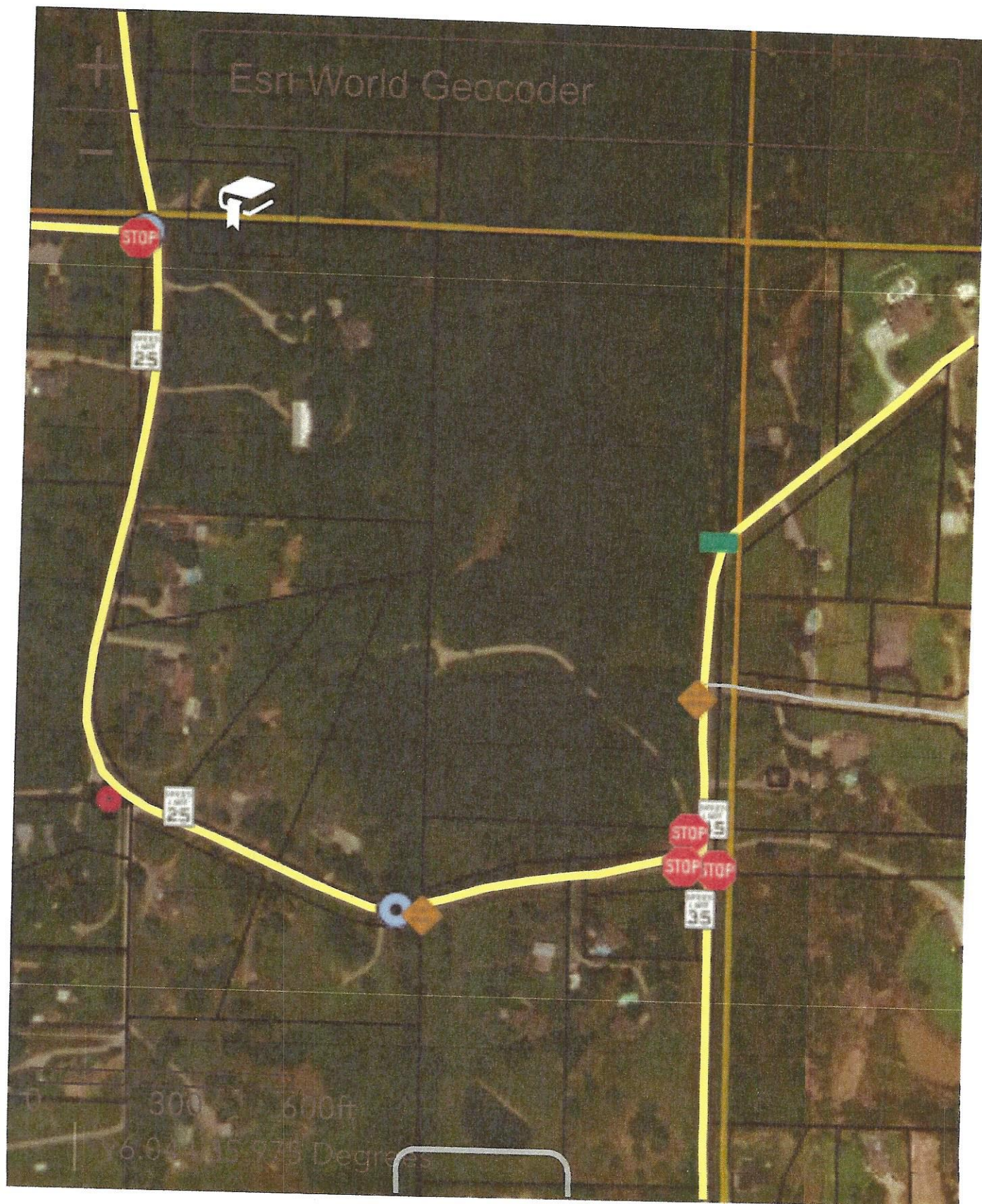
