Canadian County District #3 is seeking bids for Manning Road Project.

**Specifications:**

2 ½" Superpave S4 (PG 70-28) overlay of Manning Rd from I-40 to Jensen (approx. ½ mile)

The asphaltic material is to be hauled, placed (FOB jobsite) and compacted as per Oklahoma Department of Transportation (ODOT) specifications, current edition. Tack Coat is to be placed Incidental to the asphalt bid.

All materials comply with ODOT specifications, current edition.

Smooth transition shall be obtained in all directions at intersections and bridge approaches.

Contractor shall be responsible for all Traffic Control.

The awarded vendor will be presented a written contract to be executed and returned to Canadian County within 7 calendar days from the date of Award.

All work on the project to be complete by November 2, 2018. Liquidated damages of \$500 per calendar day will apply after that.
