

Canadian County District #1 is seeking bids for:

2 or more miles of asphalt laid in place on Waterloo Rd. (aka Azalea St) (aka 248th St) from Gregory Rd. going west

Road width: 24'

Details: 5" of asphalt is to be laid in place. District one work forces will stabilize the subgrade and prepare for paving so it will be ready for application.

S3 (pg 64-22) Hot Mix hauled and in place (FOB jobsite) 3" Base Course

S4 (pg 64-22) Hot Mix hauled and in place (FOB jobsite) 2" Surface Course

To include driveway entrances to homes and/or businesses to the right of way

Tuesday, October 30, 2018 at 9:00 a.m.**

Awarded vendor will be presented a written contract within two weeks from the award date for signature and final approval by the Board of County Commissioners. Awarded vendor must coordinate with the county to ensure that asphalt is laid within two weeks of the base being applied, and must have the project completed no later than the last day of March, 2019.

Bids will be received beginning at 9:30am on Tuesday, November 13, until 9:30am on Monday, November 19, 2018.

Bids shall be accompanied by:

- A certified check, cashier's check or bid bond equal to five percent (5%) of the bid, which shall be deposited with the awarding public agency as a guaranty; or

An irrevocable letter of credit terms the Construction and Properties Division of the Office of Management and Enterprise Services prescribes, issued by a financial institution insured by the Federal Deposit Insurance Corporation or the Federal Savings and Loan Insurance Corporation for the benefit of the state, on behalf of the awarding public agency, in an amount equal to five percent (5%) of the bid. The awarding public agency shall deposit the irrevocable letter of credit with Division.

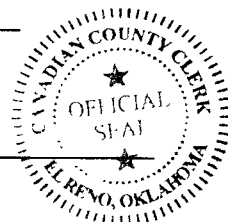
