NOTICE IS HEREBY GIVEN that Caddo County will receive sealed bids at that the County Clerks Office, Attn: Carol Butler, Purchasing Agent, Caddo County Clerk's Office, P.O. Box 68, Anadarko, OK 73005 for furnishing all labor and materials for:

Sections 10 & 15, T12N, R11W
Grading, Drainage and Surfacing
Caddo County, Oklahoma

Bidding documents may be obtained from the Caddo County Clerks Office, P.O. Box 68, Anadarko, OK 73005. Free electronic copies (PDF on USB) of the plans and specifications may be obtained at the office Caddo County Clerks Office. Copies of the USB will be mailed for a fee of \$ 5.00.

Office hours are Monday through Friday from 8:30am to 4:30pm.

Mandatory Pre-Bid Meeting is scheduled for September 26th, 2023 at 1:00pm in the Commissioner Board Room at the Caddo County Courthouse.

Bids will not be accepted after 4:00 pm, CST, Friday, October 6th, 2023. Bids filed as provided herein will be publicly opened in the County Commissioners' Board Room in the Caddo County Courthouse at 9:30am, Monday, October 10th, 2023.

Caddo County Oklahoma seeks an experienced qualified firm(s) to provide all, labor, supervisions, tools, equipment and incidentals necessary for Construction of Cummins Road from US 281 west for approximately one half mile.

All bids must include assurances that the following provisions will be complied with:

1. Federal Labor Standards Provisions
2. Equal Opportunity Provisions
3. FHWA 1273
4. FAR Part 52 – Solicitation Provisions and Contract Clauses
5. Assurances that surety companies executing bonds appear on the Treasury Department's list and are authorized to transact business in the State where the project is located.

The following information shall be provided to the Caddo County Clerk for obtaining a copy of the plans and specifications:

1. Company Name and Mailing Address where addendums, if any, can be sent by overnight service.
2. Contact Name responsible for receiving any addendums, Phone Number and email address and/or Fax number.

Bids received more than ninety-six (96) hours, excluding Saturdays, Sundays and holidays, before the time set for opening of bids, as well as bids received after the time set for opening of bids, will not be considered and will be returned unopened.

All bids must be accompanied by a certified or cashier's check, Bidders Bond, or irrevocable letter of credit in the amount of not less than five percent (5%) of the bid, made payable to the "Caddo County"; and in the event that Caddo County shall award the contract to the bidder and the bidder shall fail, within fifteen (15) days from the making of such award, to enter into the contract and furnish the bonds and insurance as required, the amount of the certified check shall be retained by the Caddo County as liquidated damages; or, if bid bond or letter of credit is submitted, the amount thereof shall then be immediately due and payable.

The bidder to who a contract is awarded will be required to furnish public liability and workmen's compensation insurance, performance, statutory and maintenance bonds acceptable to Caddo County, in conformity with the requirements of the proposed contract documents. The performance, statutory and maintenance bonds shall be for one hundred (100%) of the contract price. The Bonds shall be obtained from companies holding Certificates of Authority as acceptable sureties (31 CFR 223).

Caddo County shall reserve the right to reject any or all bids and to waive any minor technicalities in bidding. No bid may be withdrawn for a period of sixty (60) days after the opening thereof.

The Bidder must use the provided bid forms and affidavits, and all forms must be signed and notarized/attested. The Bidder must file the bid in a sealed envelope. All bids must be typewritten or in ink. One (1) copy addressed to the Caddo County Clerk's Office, Carol Butler, will be submitted, and that copy must be sealed and clearly marked with the name of the Bidder and identified as follows:

Cummins Road, Opening Date October 10th, 2023, Name & Address written on the OUTSIDE of the envelope.


