BID 2024-14 CADDO COUNTY LAKE ACCESS ROAD PROJECT ASPHALT OVERLAY N 2540/E 1260/N 2550

- Line item includes contractor's expense, material, delivery and placement of the 411C Superpave Type S3 (PG 64-22 OK). The proposed project begins at the intersection of E 1250 Road and N 2540 Road and extends South 1 mile to E 1260 Road, then extends East 1 mile to N 2550 then South 0.53 miles to Copperhead Road. Establishing a 22 foot wide by 2 inch asphalt road.
