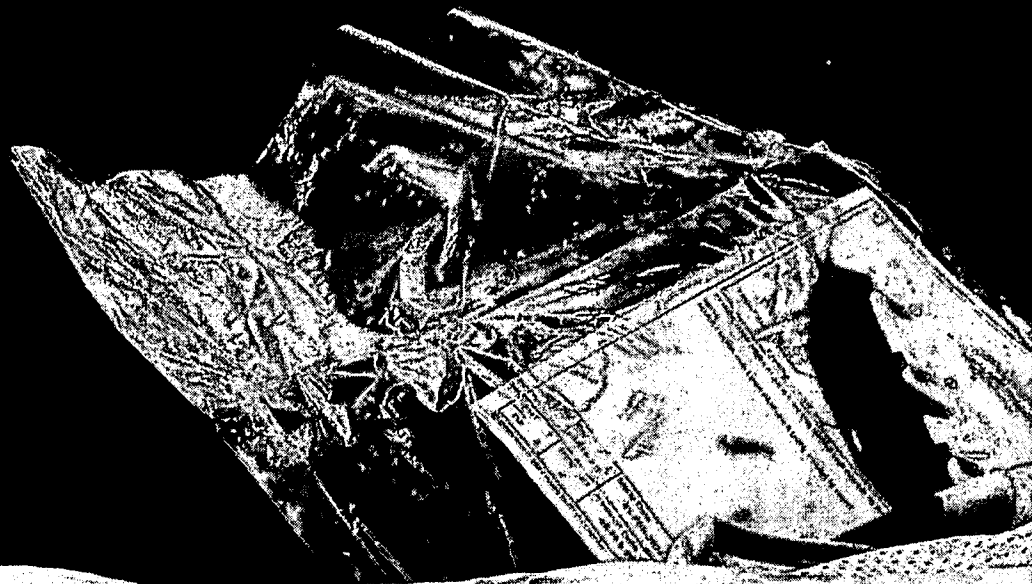

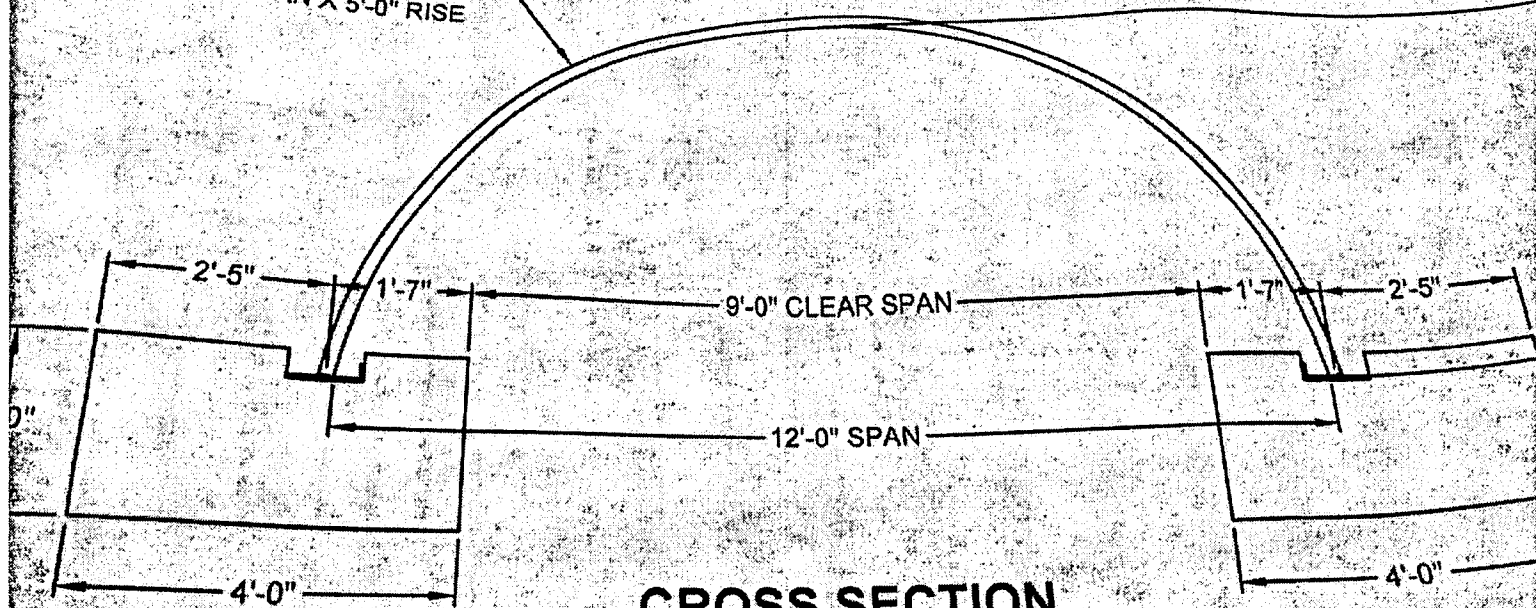

12'-0" SPAN X 5'-0" RISE



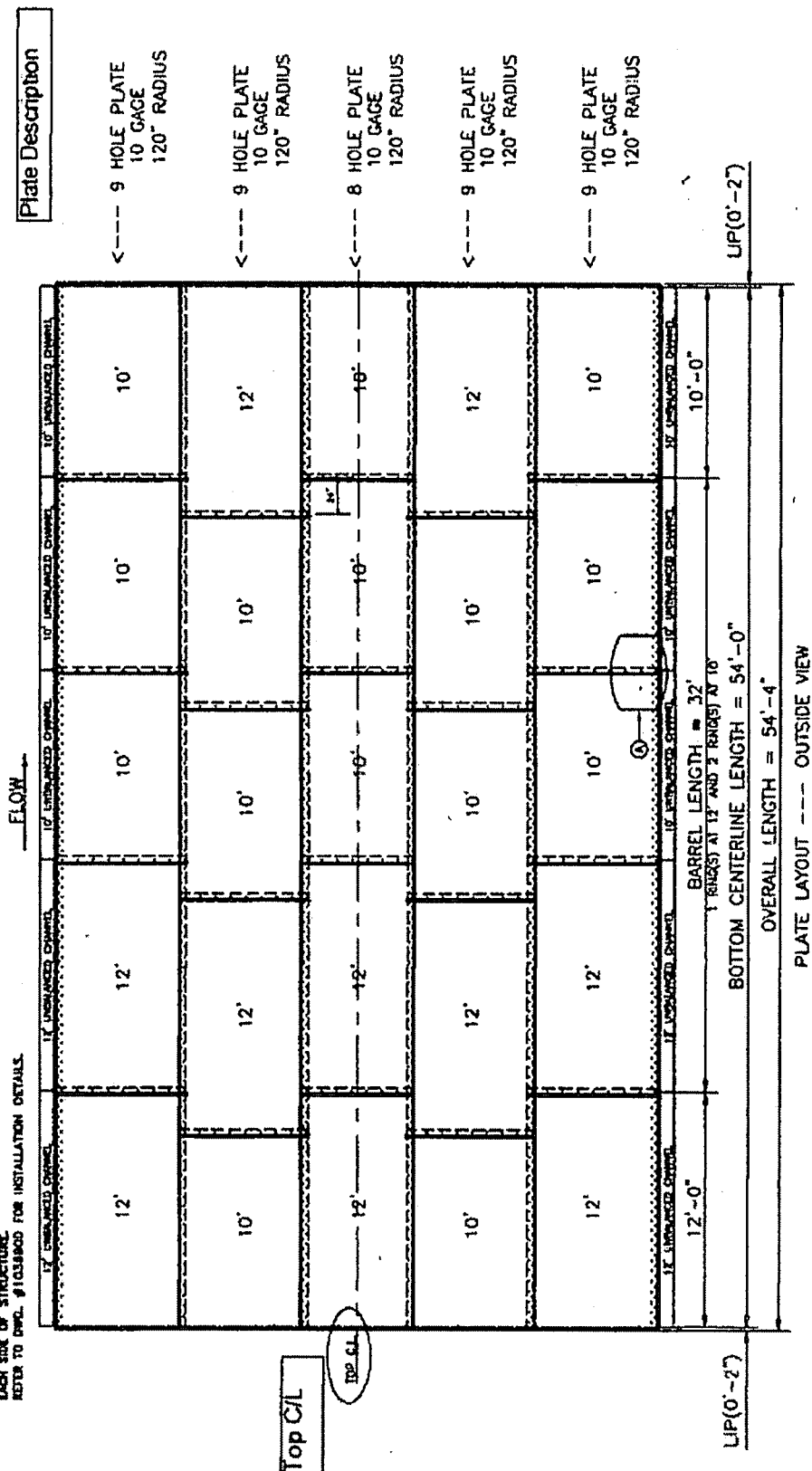
CROSS SECTION
