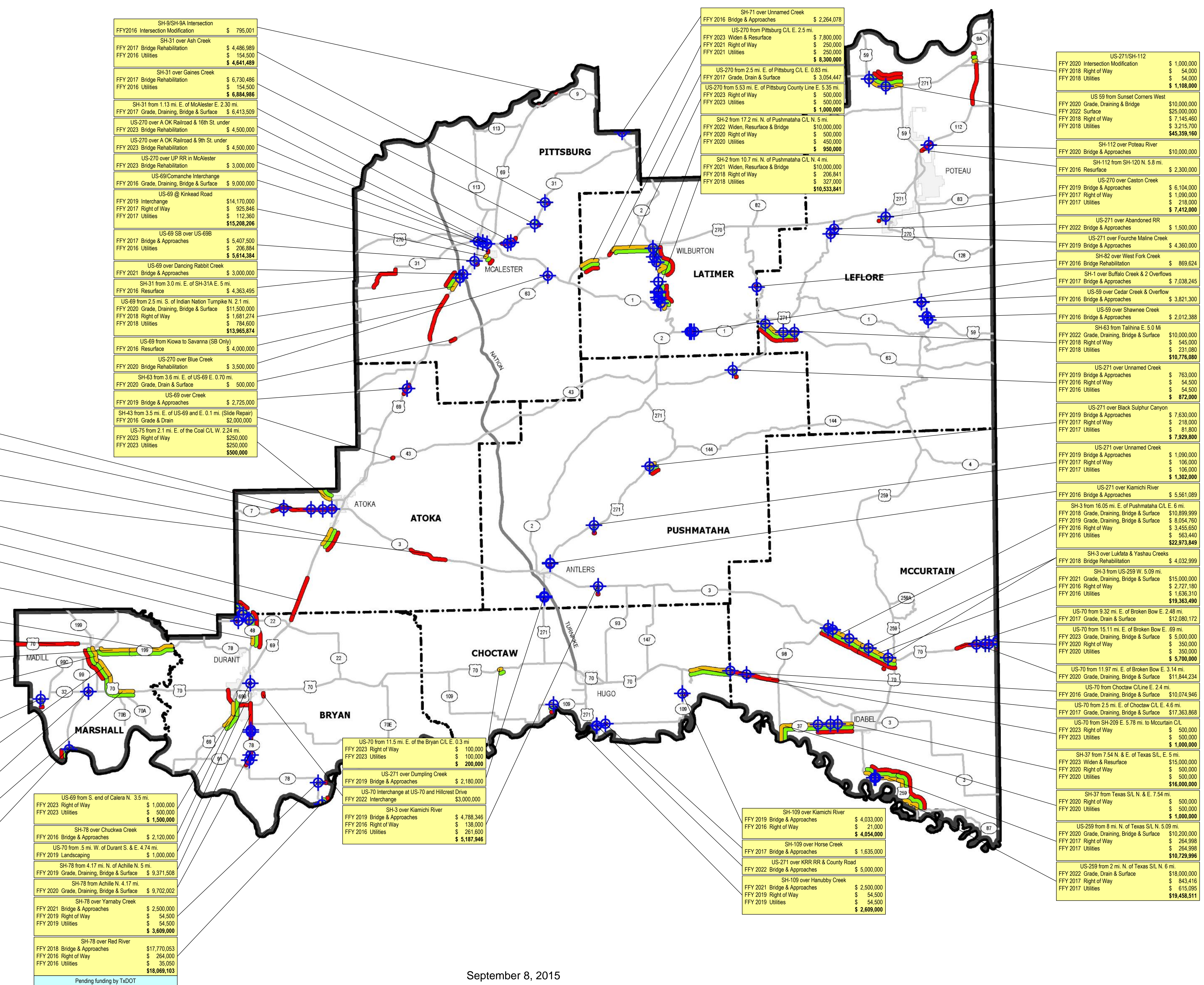
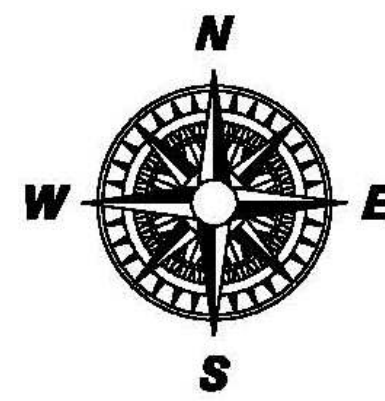
## 2016 to 2023 Construction Work Plan
