### THE TRANSPORTER





## DBESUPPORTIVE SERVICES CORNER

### **TRAINING**


This year funding will no longer be available for DBE Program Association Memberships. However, funding is available for training. Funds are available for up to five (5) DBE firms and limited to \$1000.00 each. Training must be necessary to achieve proficiency to compete, on an equal basis, for ODOT contracts and subcontracts. The training must be requested on the DBE Training Grant Requirement Form (insert) two (2) months in advance of the training date. Once approved the funds are issued on a first come first served basis.

## FEDERAL ACQUISITION REGULATION (FAR) AUDITS

A limited number of funding opportunities are available for those DBE's that provide contracted professional services to ODOT and may require an audit to comply with ODOT's policy for professional services contract consideration.

Funding is available up to (5) firms, limited to \$5,000.00 each. To request funds, select a certified public accounting firm that is familiar with FAR audits and request a letter of intent.

After selecting a firm, submit a request to the DBE Supportive Services along with the letter of intent on the audit firm's letterhead. Include the audit objective, audit procedures or work to be performed, and the cost and other relevant information, to the DBE Supportive Services Coordinator.





# OKLAHOMA DEPARTMENT OF TRANSPORTATION CIVIL RIGHTS DIVISION, EXTERNAL PROGRAMS DISADVANTAGED BUSINESS ENTERPRISE (DBE) PROGRAM TRAINING GRANT REQUIREMENTS

**Purpose:** To assist in paying tuition costs associated with training that can enhance the abilities of a qualifying DBE Firm to participate in the federal-aid highway program, either in the area of professional services or construction.

Criteria: Qualifying applications will be approved on a first-come, first-serve, funds available basis. No training will be paid for unless prior approval is obtained from ODOT, Civil Rights Division, DBE Programs. Submit training request at least two months before date of event. Incomplete requests will not be approved.

Who Qualifies? Owners and Key Employees of currently certified DBE firms.

**What Qualifies?** Training that can enhance a DBE's ability to obtain work in the federal-aid highway program. Examples would be; estimating, accounting, safety, etc. Training must be offered and held at an accredited Institution.

**Travel Reimbursement?** None – mileage, meals and lodging will be the DBE firm's responsibility.

**Out of State DBE Firms:** Out of State DBE Firms are highly encouraged to contact their home State DBE Supportive Services Program for training opportunities.

In addition to the above mentioned grant requirements, Out of State DBEs must be:

Certified in the State of Oklahoma

**How Much?** To the extent funds are available, the training limit is \$1,000 per qualifying DBE firm per federal fiscal year (6/30/14 - 5/31/15).
