



Notice of Public Hearing

All interested persons are given notice that a public hearing will be held Tuesday, April 27, 2004, from 6 to 8:00pm in the Holiday Inn located at 1010 N. Garnett Road, Tulsa. At this time, the public will be given opportunity to express their views regarding the proposed location and major design features of a proposed project to reconstruct US 412 and SH 412P in Tulsa, Rogers and Wagoner Counties. US 412 improvement will be on existing alignment and reconstructed to a multi-lane facility from the I-44/I-244 interchange extending east approximately 12 miles to the Verdigris River. US 412 will be upgraded to a fully control access facility with improved interchanges and new interchanges added in specific locations throughout the mile corridor, with frontage roads provided at certain locations. SH 412P will be constructed as a two-lane facility on mostly new alignment.

At this public hearing, instead of a formal presentation, citizens will have the opportunity to review and comment on the US 412 and SH 412P Environmental Assessment document, view prepared displays, ask questions from representatives of the Oklahoma Department of Transportation regarding environmental impacts, funding, right-of-way acquisition and relocation assistance, tentative construction schedules, and location and major design features of the alternatives under consideration, all at their convenience, between hours of 6:00 p.m. and 8:00 p.m.
