COUNTY:

As a result of the completion of Construction Projects F-59(45) and F-59(55), the following actions are necessary to implement needed State Highway Route and System revisions between the cities of Ardmore and Madill.

Redesignate US 70 as SH 199, beginning at its junction with I-35 in Ardmore and extending east and southeast 26.43 miles to its junction with existing US 70 - SH 199 (Wiggs Street and 1st Street) just north of Madill.

Redesignate US 77 Business in Ardmore as US 70, beginning at its junction with I-35 and extending east 0.74 mile to US 77.

Redesignate SH 199 as US 70, beginning at its junction with US 77 in Ardmore and extending east 21.49 miles to existing US 70 - SH 199 (Wiggs Avenue and 1st Street) just north of Madill.


Add US 70 designation to I-35 in Ardmore from its junction with new SH 199 south 2.48 miles to its junction with new US 70.

Add US 177 designation to new SH 199, from its junction with existing US 177 at Dickson southeasterly 15.27 miles to its junction with new US 70 (Wiggs Avenue and 1st Street) just north of Madill.

The rerouting of US 70 and the extension of US 177 must be submitted to the American Association of State Highway and Transportation Officials for approval.

These actions will become effective upon approval by the State Transportation Commission and AASHTO.

ITEMS PRESENTED BY THE ASST. DIRECTOR-FISCAL & PROGRAMS - Mr. Bradley

#### ITEM 100. ADDITIONS TO THE CONSTRUCTION PROGRAM:

a) TULSA COUNTY. Mr. Bradley recommended that the Commission approve a bridge repair project, I-244 over US 64 in Tulsa, as an addition to the Construction Program. The estimated cost is \$40,000. The bridge was damaged on June 10, 1984, when an out-of-control truck rolled over the bridge parapet to the ground below and burned. Plans can be prepared for an August bid opening.

Add US 70 designation to I-35 in Ardmore from its junction with new SH 199 south 2.48 miles to its junction with new US 70.

Add US 177 designation to new SH 199, from its junction with existing US 177 at Dickson southeasterly 15.27 miles to its junction with new US 70 (Wiggs Avenue and 1st Street) just north of Madill.

The rerouting of US 70 and the extension of US 177 must be sumitted to the American Association of State Highway and Transportation Officials for approval. These changes will be effective upon its approval.

b) GRANT COUNTY. Mr. Murphy recommended that the Commission approve the following revision to the State Highway System necessitated by the construction of FAS-2712(105), southwest of Lamont.

Add to the State Highway. System a segment of highway on new alignment to be designated SH 74, beginning at a tie with the present facility and extending northerly 3.14 miles to a connection with US 60.

Add SH 74 designation to US 60, beginning at its junction with the new facility and extending easterly 1.15 miles to a tie with existing US 60-SH 74.

Remove from the State Highway System 5.49 miles of old highway replaced by the new facility. This segment of old SH 74 is returned to the appropriate local jurisdiction for further maintenance or abandonment.

A Removal Public Hearing was held June 14, 1984 in accordance with State law.

ITEM 107. ROGER MILLS COUNTY. Mr. Murphy recommended that the Commission approve the County's request for state supervision of construction on RS-6508(105)C, 3.0 miles of grade, drain and surface from SH 30, 5.0 miles south of SH 33, and extending west. Total estimated construction engineering cost is \$48,800 (75% Federal funds \$36,600; 25% State funds \$12,200).

ITEM 105. FY 85 DEPARTMENT OF TRANSPORTATION OPERATING BUDGET. Mr. Bradley told the Commission that at the beginning of each fiscal year the Department is required to file with the Office of State Finance a Budget Work Program showing the proposed use of all funds available to the Department during the fiscal year. Mr. Bradley recommended that the Commission approve the FY 85 Operating Budget for the Department of Transportation as included herein and made a part of the record.

Mr. Bradley said this budget is based on funding provided by the Department's FY 85 Legislative Appropriation (HB 1534) and those dedicated state highway funds estimated to be available to the Department during FY 85 from motor fuel and related revenues.

Mr. Bradley briefly reviewed the various allocations. He said the Department has made every effort to minimize administrative and operational expenses to provide maximum funding for the Construction Program. He said during the year it may be necessary to transfer funds among administrative and operational units to meet changing circumstances, and he recommended that the Director-Chief Engineer be authorized to make reasonable adjustments of the budget elements established for Highway Administration, Engineering, Operations and Maintenance, and that Assistant Directors be authorized to make adjustments between Divisions and Branches under their supervision within the total funds budgeted for all such Divisions or Branches without further Commission action.
