This action is necessitated by the realignment of SH 33 and US 59 in Delaware County.

Remove from the State Highway System 5.65 miles of old highway beginning at a tie with the new alignment just west of West Siloam Springs and extending west to a tie with existing SH 33.


This segment of old highway is returned to the appropriate local jurisdiction for future maintenance or abandonment.

Add to the State Highway System a segment of new highway to be designated as US 59 and SH 33 beginning at a tie with the old highway just west of West Siloam Springs and extending west 5.73 miles to a tie with the old highway.

This action will become effective upon completion and opening to traffic of the new facility, Project No. F-398(25).

The US Route designation is subject to approval by AASHTO.

ITEM 184. REVISIONS TO THE STATE HIGHWAY SYSTEM:

a) CREEK COUNTY. Mr. Murphy recommended that the Commission approve a revision to the State Highway System necessitated by the realignment of US 75 Alternate at Polecat Creek just south of Sapulpa, as follows:

Add to the State Highway System a segment of new highway to be designated as US 75 Alternate beginning at a tie with the existing alignment approximately two miles north of Kiefer and extending northwesterly approximately 1.98 miles to a tie back to the existing alignment at the south edge of Sapulpa.

Remove from the State Highway System a segment of old road designated as US 75 Alternate beginning at a tie with the new alignment approximately two miles north of Kiefer and extending northwesterly approximately 2.10 miles to a tie back to the new alignment at the south edge of Sapulpa.

This segment of old highway is returned to the appropriate local jurisdiction for future maintenance or abandonment.

The US Route designation is subject to approval by AASHTO. Removal Public Hearing was held October 14, 1981.

b) DELAWARE COUNTY. Mr. Murphy recommended that the Commission approve a revision to the State Highway System necessitated by the realignment of SH 33 and US 59 in Delaware County, as follows:

Remove from the State Highway System 5.65 miles of old highway beginning at a tie with the new alignment just west of West Siloam Springs and extending west to a tie with existing SH 33.

This segment of old highway is returned to the appropriate local jurisdiction for future maintenance or abandonment.

Add to the State Highway System a segment of new highway to be designated as US 59 and SH 33 beginning at a tie with the old highway just west of West Siloam Springs and extending west 5.73 miles to a tie with the old highway.

This action will become effective upon completion and opening to traffic the new facility, project F-398(25).

US Route designation is subject to approval by AASHTO. Removal Public Hearing was held October 14, 1981.

c) OSAGE COUNTY. Mr. Murphy recommended that the Commission approve a revision to the State Highway System necessitated by the realignment of SH 20 in the Skiatook Reservoir Area, as follows:

Add to the State Highway System a segment of new highway to be designated as SH 20 beginning at a tie with the old highway just west of Skiatook and extending west across the lake to a tie with the old alignment on the west side of the lake, a distance of approximately 7.45 miles.

Remove from the State Highway System a segment of old highway beginning at a tie with the new alignment just west of Skiatook and extending westerly to a tie with the new alignment on the west side of the lake, a distance of approximately 7.90 miles. This segment of old highway is returned to the appropriate local jurisdiction for maintenance or abandonment.
