
This action is necessitated by the realignment of US 59 at the Adair - Sequoyah County line, Construction Project TQF-329(35).

Add to the State Highway System a segment of highway on new alignment to be designated US 59, beginning at a tie with the old facility in Adair County and extending south 1.79 miles to a connection with the existing highway in Sequoyah County.

Delete from the State Highway System 2.01 miles of old highway replaced by the new facility. This segment of old highway is returned to the appropriate local jurisdiction for further maintenance or abandonment. A Removal Public Hearing was held August 17, 1982 in accordance with State Law.

This revision will become effective upon approval by the State Transportation Commission.
