SUBJECT: Revision to the State Highway

System - Relocation US 62 - SH 10

at Ft. Gibson

COUNTY: Muskogee

The following actions are necessary to implement needed State Highway System revisions in the Fort Gibson area as a result of the completion of Construction Projects FAP-F-404(45) and FAS-RS-5123(105).

Add to the State Highway System a segment of new highway to be designated US 62, beginning at a connection with the old facility southwest of Ft. Gibson and extending northeasterly 4.27 miles to a tie with existing US 62 east of Ft. Gibson.

Add to the State Highway System a segment of new highway to be designated SH 10, beginning at a tie with present SH 10 and extending north .10 mile to a connection with new US 62.

Add SH 10 designation to the new highway, beginning at the junction of new SH 10 and extending northeasterly 3.53 miles to a connection with the present highway.

Add to the State Highway System a segment of new highway to be designated SH 80, beginning at its junction with the new highway and extending northwest 1.12 miles to its junction with existing SH 80 in Ft. Gibson.

Redesignate a segment of old US 62 in Ft. Gibson as SH 80A, beginning at its junction with SH 80 and extending east .19 mile to its junction with present SH 80A.

Remove from the State Highway System that portion of old highway designated US 62 - SH 10, beginning at its junction with the new highway southwest of Ft. Gibson and extending northeast to its junction with SH 80 in Ft. Gibson.

Remove from the State Highway System that portion of old highway designated US 62 - SH 10 beginning at its junction with SH 80A in Ft. Gibson and extending east to a tie with the new facility.




The segments of old highway removed from the State Highway System are returned to the appropriate local jurisdiction for further maintenance or abandonment. Removal Public Hearings were held in accordance with State Law.

The rerouting of US 62 must be submitted to the American Association of State Highway and Transportation Officials for approval.
