Relocation of US 62, US 277 & SH 9

Between Blanchard and Tabler

COUNTY:

Grady

This item is necessitated by the relocation of US 62, US 277 & SH 9 at Middleburg and northeast of Tabler in Grady County. Construction Project STP-26B (231) and STP-26B (232).

Add to the State Highway System, a segment of new highway to be designated US 62, US 277 & SH 9, beginning at a tie with the existing facility northeast of Tabller in Section 19, T7N, R5W and extending northeasterly approximately 5.21 miles to a connection with the present facility west of Blanchard in Section 35, T8N, R5W (see map 1).

Add to the State Highway System, a segment of new highway to be designated US 62, US 277 & SH 9, beginning northeast of Tabler at a tie with the existing facility in Section 26, T7N, R6W and extending easterly approximately 1.27 miles to a tie with the existing facility northeast of Tabler in Section 19, T7N, R5W (see map 2).

Remove from the State Highway System, a portion of US 62, US 277 & SH 9, beginning southwest of Middleberg in Section 19, T7N, R6W and extending northeasterly approximately 5.58 miles (see map 1).


Remove from the State Highway System a portion of US 62, US 277 & SH 9, beginning northeast of Tabler in Section 26, T7N, R6W and extending easterly approximately 1.33 miles (see map 2).

Sections of old US 62, US 277 & SH 9 highway and right-of-way will be transferred to the appropriate local jurisdiction for further maintenance or abandonment. In accordance with state law, a Public Removal Hearing was held November 9, 1995.

These revisions will become effective upon approval by the State Transportation Commission, and upon completion of certification that the old roadway meets mandated criteria.



ITEM 172. MINUTES. The secretary recommended that the Commission approve the minutes of the meeting of October 1, and Bid Opening Report of October 26, 1984.

ITEMS PRESENTED BY THE ASST. DIRECTOR-FISCAL & PROGRAMS - Mr. Bradley

ITEM 173. ADDITIONS TO THE CONSTRUCTION PROGRAM:

ROGERS COUNTY. Mr. Bradley recommended that the Commission approve an allocation of Construction funds for 50% of the cost of an Interstate Maintenance Contract to resurface a section of I-44 from the Tulsa-Rogers County line east 3.1 miles. The total estimated cost is \$330,000. The Division will finance 50% (\$165,400) from Interstate Special Maintenance Funds available for that Division. The Construction Fund allocation is \$165,400-the remaining 50%.

- b) SEQUOYAH COUNTY. Mr. Bradley recommended that the Commission approve an addition to the Construction Program for the replacement of the Garrison Creek Bridge on SH 64-D south of Dora. A short section of new roadway construction will be necessary in order to construct the bridge. The total estimated cost of the bridge and roadway is \$800,000, and will be financed with 80% Federal "BR" Funds and 20% State Funds. The existing bridge will remain in place to handle traffic while the new bridge is being built.
- c) WAGONER COUNTY. Mr. Bradley recommended that the Commission approve an addition to the Construction Program to replace the Flat Rock Creek Bridge on the old two lanes of US 69 north of Wagoner. The two new parallel lanes through the area are complete. The old bridge is substandard in width and load-bearing capacity, and the deck has deteriorated and is no longer serviceable. The estimated cost to replace the bridge is \$310,000 and will be financed with 80% Federal Bridge Replacement Funds and 20% State Funds. The project will be on the January 1985 letting.
- d) CARTER COUNTY. Mr. Bradley recommended that the Commission approve an addition to the Construction Program to add ramps to the existing crossing of 12th Street over I-35 at Ardmore to provide a connection with the Interstate roadway. Based on preliminary planning studies, the Interchange appears justified from a traffic services standpoint in that it will permit access to the Interstate from the industrial area and other development adjacent to the Uniroyal facility west of I-35 and to the developing areas east of I-35. This will require Federal Highway Administration approval, and the Department will submit detailed cost/benefit studies showing the user benefits to justify the construction cost of the facility. The estimated cost is \$2,200,000, and the project will be financed with 75% Federal Funds and 25% State Funds. This project is eligible for Interstate Construction Funds.
- e) PONTOTOC COUNTY. Mr. Bradley recommended that the Commission program a project to modify the median opening and adjacent roadway on SH 3-W just southeast of SH 3-W/SH 19 interchange west of Ada. The work will consist of widening the median opening and the adjacent 4-lane paving through the area to permit turning movements by trucks and other vehicles without creating a hazard to through traffic, at an estimated cost of \$400,000. Work will be done by contract.
- f) MC CLAIN COUNTY. Mr. Bradley recommended that the Commission program the replacement of three substandard bridges on SH 74-B:
 - 1. 41' x 23' Timber Span (X0895) \$120,000
 - 2. 131' x 19' Timber Span (X0496) 500,000
 - 3. 36' x 19' Timber Span (XO596) 210,000

These bridges totalling \$830,000 will be financed with 80% Federal Bridge Replacement Funds, and 20% State Highway Funds. (Federal share \$664,000; State share \$166,000)



- g) GRADY-MC CLAIN COUNTIES. Mr. Bradley recommended that the Commission program a project to reconstruct approximately 12.0 miles of US 62/US 277 beginning at Tabler, approximately 6.5 miles east of Chickasha and extending northeast to Blanchard, at an estimated cost of \$4,430,000. The new construction will consist of widening the surface to 24-feet, and constructing 6-8 ft. payed shoulders and then resurfacing the full roadway width.
- h) COTTON COUNTY. Mr. Bradley recommended that the Commission program a project to replace the East Cache Creek bridge and overflow structures on SH 5 west of Temple. There are four structures involved, and a section of roadway approximately one mile in length. The estimated cost of the four replacement bridges is \$1,775,000; the estimated roadway cost is \$1,300,000 for a total project cost of \$3,075,000. The work will be financed with 80% Federal Bridge Replacement Funds, and 20% State Highway Funds.
- i) DEWEY COUNTY. Mr. Bradley recommended that the Commission program a project to remove the SH 34 overpass structure crossing the abandoned MK&T Railroad approximately five miles south of Carmargo. The estimated cost to remove the structure and construct a short section of replacement roadway is \$200,000.
- j) TULSA COUNTY. Mr. Bradley recommended that the Commission program a project to replace four bridges on US 169 north of Collinsville. The first bridge is at Horsepen Creek approximately 1.5 miles north of Collinsville. The others are the Caney River Bridge and two overflow structures about 2.5 miles north of Collinsville. The estimated cost of replacing these four bridges including roadway is \$4,300,000. This work will be financed with 80% Federal Bridge Replacement Funds and 20% State Funds.

ITEM 174. SPOT SAFETY IMPROVEMENT PROGRAM. Mr. Bradley recommended that the Commission establish a continuing Spot Safety Improvement Program to spend approximately \$3.0 million per year to improve the overall safety of the State Highway System. This money will be used to fund safety projects at locations where, for a relatively small expenditure of funds, improvements can be made that will eliminate or significantly lessen an existing hazardous condition. Projects included in the new Spot Safety Improvement Program are primarily those which can be done within a short period of time to provide immediate relief to a specific problem area.
