SUBJECT: Revision to the State Highway System US 77

COUNTY: Canadian, Cleveland, McClain, Oklahoma and Pottawatomie

The following actions are necessary to implement needed State Highway Route and System revisions in the Oklahoma City Area.

Transfer from the State Highway System that portion of State Highway 3 on May Avenue from the Northwest Highway south to I-240, that portion of SH 3, US 270 and US 66B on May Avenue from I-240 south to NW 23rd St., and that portion of SH 3 on May Avenue from NW 23rd Street south to S.W. 29th Street, and that portion of SH 3 on SW 29th Street from May Avenue east to its junction with US 270 south of Harrah.

Transfer from the State Highway System that portion of US 270 and US 66B on NW 23rd Street, from May Avenue east to Broadway and that portion of US 270 from Lincoln Boulevard east to I-35.

Transfer from the State Highway System that portion of SH 74 from its junction with I-35 at Norman and extending west on Robinson and north on Western Avenue to the junction of I-240 in Oklahoma City.

Transfer from the State Highway System that portion of SH 152 on SW 29th Street from I-240 east to May Ave.

Transfer from the State Highway System that portion of SH 170 from its junction with I-35 and extending east on Britton Road to Hiwassee Road in Jones.

Transfer from the State Highway System that portion of SH 4 from its junction with US 66 at Yukon and extending southerly and easterly to May Avenue in Oklahoma City.

The above are hereby transferred to the appropriate local jurisdiction for further maintenance or abandonment.

Upon completion of construction of Memorial Rd., transfer from the State Highway System that portion of SH 170 from its junction with US 77 and extending east to I-35.

Upon completion of construction of the Shields Blvd. extension and the Lincoln Blvd. connection to Reno Street, transfer from the State Highway System that portion of US 77 from SW 44th Street and Shields Blvd. extending west on SW 44th St., north on Robinson and Broadway Avenue to NW 23rd St. and east on NW 23rd Street to Lincoln Blvd.

Upon completion of construction, the above are hereby transferred to the appropriate local jurisdiction for further maintenance or abandonment.

A public hearing has been held on these removals as required by State Law.

Remove US 270 designation from US 66, beginning at the junction with I-40 west of El Reno and extending east to I-240 and from I-240 and US 66 east to May Avenue.

Remove US 270 and US 66B designation from that portion of N 23rd St., beginning at Broadway Avenue extending east to Lincoln Blvd., also remove US 270 designation from N 23rd St., beginning at I-35 and extending east to Harrah and remove US 270 designation from existing US 270 beginning at US 62 in Harrah extending south and east to I-40 NW of Shawnee.

Remove SH 3 designation from the Northwest Highway, beginning at MacArthur Blvd. and extending southeast to May Avenue and from existing SH 3 beginning at the junction of US 270 south of Harrah and extending southeast to I-40 NW of Shawnee.

Remove SH 66A designation from the Northwest Highway, beginning at May Avenue and extending southeast to I-240.

Remove US 66B designation from Lincoln Blvd. beginning at NE 23rd St. and extending north to I-240.

Remove SH 74 designation from I-35, beginning at the SH 74 junction south of Norman north to Robinson St. in Norman, that portion on I-240 from Western Ave., westerly and northerly to Airport stub, that portion on Airport stub from I-240 west to MacArthur Blvd, that portion on MacArthur Blvd. from Airport stub north to the Northwest Highway.

Redesignate as SH 270 that portion of existing US 270 beginning at the junction of US 62 in Harrah and extending south and east to the junction of US 177.

Add US 270 designation on I-40 from the junction of US 66 west of El Reno east to the present I-40, US 270 junction northwest of Shawnee.

Add SH 3 designation on MacArthur Blvd. from the Northwest Highway south to Airport stub, east on Airport stub to I-240, south and east on I-240 to I-40, east on I-40 to the present I-40, SH 3 junction northwest of Shawnee.

Add SH 3A designation on the Northwest Highway, beginning at I-240 extending northwest to MacArthur.


Upon completion of Shields Blvd. extension and the Lincoln connection to Reno Ave., add US 77 designation to Shields Blvd. from SW 44th Street north to Reno Ave. on Reno from Shields Blvd. east to the Lincoln Blvd. connection, on Lincoln Blvd. from Reno Avenue north to NE 23rd Street.

The Department recommends approval of this action.

- 1. SH 170, which presently extends along Memorial Road from the Broadway Extension east to I-35, and from I-35 along Britton Road east to Hiwassee Road, to be deleted from the State Highway System when construction on the route has been completed.
- 2. SH 4, from US 66 at Yukon southeasterly and easterly along Northwest 10th Street to May Avenue in Oklahoma City, to be deleted from the State Highway System.
- 3. SH 3, extending from the Northwest Highway along May Avenue then easterly along South 29th Street to its junction with US 177 in Pottawatomie County, to be rerouted as follows: beginning at the Northwest Highway and extending south on MacArthur Boulevard to the Airport Extension, then easterly along the Airport Extension to I-240, then south and east along I-240 to the junction with I-40 south of Choctaw, then easterly along I-40 to the junction of US 177 in Pottawatomie County.
- 4. US 270 from its junction with I-40 west of El Reno extending easterly along 39th Street in Oklahoma City to May Avenue, then south along May Avenue to North 23rd Street, then east along 23rd Street to the City of Harrah, then south to Southeast 29th Street, then east to the junction of US 177 to be relocated to follow I-40 from the junction west of El Reno to the junction of US 177 in Pottawatomie County.
- 5. US 77, from Southeast 44th Street and Shields Boulevard, west on 44th Street to Robinson Avenue, then north on Robinson and Broadway Avenues to 23rd Street, then east on 23rd Street to Lincoln Boulevard to be relocated to follow Shields Boulevard north to Reno Street, then east along Reno to Lincoln Boulevard, then north along Lincoln Boulevard to Northeast 23rd Street. This rerouting will be signed upon completion of projects currently underway on South Shields and on Lincoln Boulevard.
- 6. SH 74, from I-240 in Oklahoma City south along Western Avenue to Robinson Street in Norman and east along Robinson Street to its junction with I-35, to be removed from the State Highway System.
- 7. US 270, from its junction with US 62 at Harrah south to Southeast 29th Street (SH 3) to be deleted from the State Highway System.
- 8. SH 152 (SW 29th St.), between I-240 and South May Avenue to be deleted from the State Highway System.
- 9. Northwest Highway, from I-240 at Belle Isle Lake and extending westerly to MacArthur Boulevard, to be designated SH 3-Alternate.








SH/4 Removal In Oklahoma City Urban Area Canadian & Oklahoma Counties January 31, 1979





SH 170 Removal From US 77 East to 1-35 Oklahoma City February 2, 1979 Approved March 5,1979 Item 35
