

**ODOT Presents Future Outlook to Citizens; Public Meetings Scheduled** FOR IMMEDIATE RELEASE August 11, 2010 PR# 10-028

The Oklahoma Department of Transportation encourages citizens to take an active role in transportation planning policies and projects. The department is hosting a series of open house meetings across the state to receive feedback from communities on its drafts of two important planning documents.

Citizens will have the opportunity to review and comment on proposed policies which represent the core of the Statewide Intermodal Transportation Plan, also referred to as the Long Range Plan, outlines policies governing transportation planning for a minimum of 20 years into the future. It contains information and policies for highways, airports, transit, waterways, rail and pedestrians/bicyclists.

Comments will also be accepted on the Statewide Transportation Improvement Program, a short-range planning tool which educates the public on future transportation needs and assures that federal funds are spent on projects consistent with approved long-range plans. The document identifies necessary improvements of both regional significance and priority on projects such as transit, highway and others to be carried out by the state, cities and counties over the next four years. The STIP outlines the facilitation of the development, management and operation of those needs.

Comments on both the Long Range Plan and the STIP must be received by Sept. 6, 2010. Written comments may be submitted during the meetings or mailed to Oklahoma Department of Transportation, Planning & Research Division, 200 NE 21<sup>st</sup> St., Oklahoma City, OK 73105.
