Pursuant to the Section 1511 Transparency and Oversight Certification for recovery projects as required by the American Recovery and Reinvestment Act of 2009 (ARRA), enclosed is the State of Oklahoma's certification that the Oklahoma County Road and Bridge Recovery Projects and the investments represented have received the full review and vetting required by law and are an appropriate use of taxpayer dollars. This Certification is provided for the included list of Recovery Projects only and is representative of the County Road and Bridge phase of Oklahoma's Statewide program.

The projects are proposed to be financed with ARRA funding and will draw from multiple funding sources.
