Dear Secretary LaHood:

Pursuant to the Section 1511 Transparency and Oversight Certification for recovery projects as required by the American Recovery and Reinvestment Act of 2009 (ARRA), enclosed is the State of Oklahoma's certification that the Oklahoma Department of Transportation Recovery Projects and the investments represented have received the full review and vetting required by law and are an appropriate use of taxpayer dollars. This Certification is provided for the attached lists of Recovery Projects only and is representative of the sixth phase of ODOT On-Highway System projects and the third phase of the ODOT Americans with Disabilities Act Pedestrian Improvement program.

These projects will be advertised by the Oklahoma Department of Transportation and are currently scheduled for construction contract bid letting in early 2010. The projects are estimated to be financed with multiple funding sources including ARRA funding. The final financing and ARRA participation levels will be determined to the extent possible at the time of authorization and we anticipate that the final financing determinations will remain subject to further review and modification until the time of the award of the resulting contracts. The State will be submitting additional certifications on behalf of the Oklahoma Department of Transportation as necessary to address any remaining ARRA project phases.

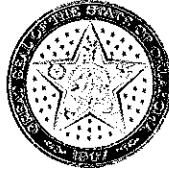


**CERTIFICATION UNDER SECTION 1511 OF
