Pursuant to the Section 1511 Transparency and Oversight Certification for recovery projects as required by the American Recovery and Reinvestment Act of 2009 (ARRA), enclosed is the Metropolitan Tulsa Transit Authority's Board of Trustees certification that the Transit Capital Assistants projects and investments represented have received the full review and vetting required by law and are an appropriate use of taxpayer dollars. This Certification is provided for the attached list of Transit Recovery projects only.

The projects have been, reviewed and approved by the Metropolitan Tulsa Transit Authority Board of Trustees, included in the Tulsa Metropolitan Transportation Planning District Transportation Improvement Program (TIP), and included in the state of Oklahoma Transportation Improvement Program (STIP).
