141. Supplemental Engineering Contracts
a) Oklahoma County - Commission District IV (E.C. 415, Supplement No. 2)

The services of Poe and Associates, Inc., will be utilized by the Department to prepare functional plans for upgrading the l-35/l-240 Interchange. A supplemental agreement is needed to evaluate the alternative designs to the Pole Road ramp access project submitted by the Crossroads Mall owners, in comparison to the completed functional design plans. Adjusted engineering fees for this supplement are $\$ 90,000.00$. The total engineering contract cost, including supplementals, is $\$ 499,000.00$. Right-of-Way authorization is scheduled for September 2005. Funding will be $90 \%$ federal funds and $10 \%$ state funds.
b) Seminole County - Commission District III (E.C. 610G, Supplement No. 4)

Wilson \& Company Engineers was previously authorized to prepare final construction plans for $\mathrm{SH}-99$ from 0.5 mile south of $\mathrm{I}-40$ extending south 4.6 miles in Seminole County. A supplemental agreement has been negotiated to update the construction documents to bring the project into compliance with current Department and AASHTO guidelines. Adjusted engineering fees total $\$ 11,700.00$. The total engineering contract cost, including this supplement, is $\$ 590,700.00$. This project is in the 8 Year Construction Work Plan with a scheduled letting date in FFY 2006. Funding will be $80 \%$ federal funds and $20 \%$ soft match credit.
c) Adair County - Commission District I (E.C. 582, Supplement No. 1)

White Engineering Associates, Inc., was previously authorized to prepare final design plans for the bridge and approaches over the Illinois River north of Watts on US-59. Design modifications to the original bridge plans are required in order to meet the Department's current design requirements. Adjusted engineering fees total $\$ 29,000.00$. The total engineering contract cost, including this supplement, is $\$ 246,000.00$. This project is in the 8 Year Construction Work Plan with a scheduled letting date in FFY 2006. Funding will be $80 \%$ federal funds and $20 \%$ soft match credit.

## ITEMS PRESENTED BY THE DIRECTOR - Mr. Ridley

147. Emergency Declaration - Tulsa County - bridge on I-244 over Mingo Road 6.4 miles east of the I-244 junction (Bridge No. 16976)

The subject bridge has been damaged by an over-height vehicle (dump truck) traveling north on Mingo Road. Division VIII forces have restricted traffic on the outside lane of the eastbound I-244 bridge, which is part of the ramp going from I-244 eastbound to US-169 southbound. Due to heavy congestion on I-244. it is critical that traffic be restored on the ramp as soon as possible. An emergency project needs to be done to repair the damage, provide a factor of safety and to restore the structural capacity of this bridge at an acceptable level to the driving public. Division VIII forces do not have the capability of repairing this bridge in a timely manner.

146. Emergency Declaration - McCurtain County - bridge on US-70 over Mountain Fork River (Bridge No. 10964)

The subject bridge has extensive damage due to metal fatigue. An emergency project needs to be done to repair the deck, fatigue cracks, provide a factor of safety and to maintain the structural capacity at an acceptable level to the driving public. Division II forces do not have the capability of repairing this bridge in a timely manner.
