CLOUR Engineering has been selected to perform design services on the Kickapoo Street project in the City of Shawnee. The Consultant will assist with the development of necessary environmental documentation and final engineering plans for rehabilitating Kickapoo Street from MacArthur Street south to US-270 Business/Kickapoo Spur. A not to exceed amount of $\$ 250,000.00$ will be established to begin the initial project investigation and development process, and associated Consultant activities will be specifically directed by task order. Construction projects are included in the 8 Year Construction Work Plan with scheduled letting dates of FFY 2008. Funding will be $80 \%$ federal funds and $20 \%$ soft match credit.

175. Supplemental Engineering Contracts
a) Cleveland County - Commission District III (E.C. 348 Supplement No. 11)

Poe \& Associates, Inc., was previously authorized to develop construction plans for the widening of I-35 beginning at S.E. $15^{\text {th }}$ Street in Oklahoma City extending south to, and including, the Shields interchange in Moore. Adjusted engineering fees total \$11,100.00. The total engineering contract cost, including supplementals, is $\$ 4,569,287.00$. This project was let in September, 2005. Funding will be $90 \%$ federal funds and $10 \%$ soft match credit.
b) Tulsa County - Commission District VIII (E.C. 573 Supplement No. 3)

HUB \& Garver (now Holloway, Updike and Bellen) was previously authorized to prepare final construction plans to upgrade US-64 from the SH-67 junction in Bixby, extending north to approximately the Arkansas River. Adjusted engineering fees for additional work required to complete the project total $\$ 17,000.00$. The total engineering contract cost, including supplementals, is $\$ 772,900.00$. This project is in the 8 Year Construction Work Plan with a scheduled letting date of FFY 2006. Funding will be $80 \%$ federal funds and $20 \%$ soft match credit.
c) Rogers County - Commission District VIII (E.C. 659 Supplement No. 3)

Benham Companies, LLC, was previously authorized to prepare environmental documents and engineering studies for the US-412 Corridor from the I-44/I-244/US-412 interchange east to the Verdigris River, including SH-412P in Rogers, Tulsa and Wagoner Counties. The total engineering contract cost, including supplementals, is $\$ 3,351,946.00$. This project is currently
scheduled in the 8 Year Construction Work Plan beginning in FFY 2007. Funding will be 80\% federal funds and $20 \%$ soft match credit.

182. Emergency Declaration - Murray County - I-35 over SH-77D, 4.8 miles north of the Carter County Line

A special inspection was made on subject bridge on October 17, 2005, revealing bearing failure. Following this inspection, Division VII forces immediately closed the outside southbound climbing lane of I-35. A follow-up inspection by the Bridge Division revealed that additional columns had significant cracking and spalling. Department forces do not have the capability to make repairs to these columns. An emergency project needs to be done to repair the columns and to maintain the structural capacity to an acceptable level to the driving public.

180. Resolution for the issuance of Grant Anticipation Notes

The Department is seeking approval of a second Grant Anticipation Notes (GANS) resolution which will authorize the Director to proceed with the issuance of $\$ 100$ million of bonds. The bond proceeds will be used to provide partial financing of the projects that have been identified in the 8 Year Construction Work Plan within these corridors.

Note: At the call for questions, Commissioner Benbrook asked how the Department arrived at the $\$ 100$ million figure. Chairman Overland called on Director Ridley who gave a brief history of our GARVEE program, and explained the corridor plan that was announced in the Governor's press release on December 30, 2003, which explained that the $\$ 514$ million funding was comprised of $\$ 300$ million in proposed bond funds and approximately $\$ 214$ million in regular federal aid. The Director went on to cite projects, dates and all other criteria used to establish a sound work plan and best utilization of these funds. The Department had requested and received prior approval for GARVEE bonds in 2002.

181. Settlement

On August 1, 2004, a person was westbound on l-244 at the intersection with Detroit Avenue in Tulsa and collided with the exit ramp attenuator. The total cost to repair the attenuator was $\$ 15,571.50$. The insurance company is proposing a settlement of $\$ 10,000.00$, the policy limit held by the insured. Title 69, Section 1002 of the Oklahoma Statutes provides the Transportation Commission with the authority to settle claims which it may have against any person for damages to facilities belonging to the Department.
