104. Engineering Contracts
a) Washington County - Commission District VIII (E.C. 1040)

The Department has selected Craig \& Keithline, Inc., to develop a preliminary engineering study for US75 from Green County Road to Frank Phillips Boulevard. The preliminary study will include traffic studies, traffic modeling, environmental documents, geometric configuration for the US-75/US-60 Interchange and survey. The consultant will also prepare construction plans for required improvements along US-75 at Price Road and US-75 at Nowata Road. Negotiated fees total $\$ 445,400.00$. Two construction projects are included in the 8 Year Construction Work Plan with the first scheduled letting date in FFY 2007. The total construction cost for both of these projects is $\$ 720,000.00$. Funding will be $80 \%$ federal funds and $20 \%$ soft match credit.
b) Statewide Load Posted Bridge Program

The Department has selected multiple engineering consulting firms to develop final construction plans for several bridges that are included in the Load Posted Bridge Program. See table in Item 104.b) narrative for details.

## 105. Supplemental Engineering Contracts

a) Pottawatomie County - Commission District III (E.C.1035, Supplemental No. 1)

Clour Engineering was previously authorized to prepare preliminary plans and perform environmental studies for a project to reconstruct Kickapoo Street in Shawnee. This supplemental agreement is for additional engineering services, and adjusted engineering fees total $\$ 53,000.00$. The total engineering contract cost, including supplementals, is $\$ 303,000.00$. The estimate for construction costs for this project is $\$ 5,500,00.00$. Funding will be $80 \%$ federal funds and $20 \%$ soft match credit.
b) Tulsa County - Commission District VIII (E.C. 646, Supplemental No. 2)

Poe \& Associates, Inc., was previously authorized to prepare an operational analysis and conduct engineering studies for l-44 from Riverside Drive to west of Yale Avenue in Tulsa. This supplement is for additional work required to complete the engineering and hydraulic studies. The negotiated fee for this additional work is $\$ 108,000.00$. This brings the total engineering contract cost, including supplementals, to $\$ 1,899,882.00$. Funding will be $90 \%$ federal funds and $10 \%$ soft match credit.

91. Presentation of resolution announcing celebration of the $50^{\text {th }}$ Anniversary of the Interstate Highway System (Mr. Ridley)

Director Ridley discussed the creation and history of the Highway Trust Fund which was designated by President Eisenhower in 1956 to initiate the construction of the Interstate System. The Director then introduced Representative Fred Perry who is House Transportation Committee Chair. Representative Perry and Senator Debbe Leftwich co-authored Joint Resolution No. 55, recognizing the $50^{\text {th }}$ Anniversary of the federal interstate system of highways. Representative Perry stated that Director Ridley was recognized on the House floor as Chairman of the national Interstate $50^{\text {th }}$ Anniversary Steering Committee to organize milestone events for this celebration. The Resolution was presented to the Commission.

Representative Perry introduced Representative Mark Liotta Appropriations and Budget - General Government and Transportation - Chair. Representative Liotta authored House Bill 1078 which provided a huge step forward for transportation funding. He promised more work for transportation funding in coming years.

## ITEM PRESENTED BY THE DIRECTOR - Mr. Ridley

## 114. Director's Report

Director Ridley discussed transportation funding for this year and the future. He stated that we should acknowledge that our Interstates are 50 years old, and that we need to address the problems of maintenance and upkeep of this system. Also, at the national and state level we need to consider how we will address freight movement that is going to increase $70-80 \%$ over the next few years and traffic that will be increasing $30-35 \%$, etc. He discussed the impact of House Bill 1078 on the future of transportation in our State. The Governor's proposal would increase funding for bridges, and references a proposed constitutional amendment that would insure that all gas and diesel taxes would go to transportation. Director Ridley asked Representative Liotta to discuss House Bill 2940.

Representative Liotta, author of House Bill 2940, discussed highlights of the Bill which encompasses part of the Governor's proposal on road funding, accelerates increase in funding in House Bill 1078, increases the cap to more than double road funding over the next four years, identifies gas and diesel taxes that currently go to General Revenue that will be used for critical bridges and annualizes the $\$ 70$ million debt service (CIP). House Bill 2940 is recognition of the last 25 years of the Legislature's inability to increase road funding for our State.
