Mr. Burrage introduced special guests, Bobby Stem, Executive Director of the Association of General Contractors, Sherry Soliz, Executive Director of Oklahoma Operation Lifesaver and Deby Snodgrass, Secretary of Commerce & Tourism. He then called on Secretary Ridley who wanted to say a few words.

Secretary Mr. Ridley said that he and Secretary Snodgrass serve together on Governor Fallin's Cabinet. He explained that Secretary Snodgrass has asked him if she could come to this meeting today and make a presentation to the Commission and the Department. So everyone please help me welcome my friend, Deby Snodgrass.

Secretary Snodgrass said that she wanted to come today and personally give thanks for our assistance. She stated, "This agency has been a tremendous partner for me personally and for my agencies during my tenure in state government".

She said that a few weeks ago we probably read in the papers about how First National Center was going to have their utilities cut off. So the Governor's office called her on Friday night at 8 o'clock and said we've worked all day on the situation with the utilities, but you're going to have to get Tourism moved out by next Thursday. It's Friday night! There are over 100 people! So we worked all weekend, got it done, it went as smoothly as possible, but our number one problem was parking; we didn't have room for another 100 cars. So this agency stepped up to help us. I've never, ever, ever, even in the private sector, seen something move so quickly. There was a lot across the way that was vacant that could be leased; and your agency built a temporary parking lot for us on that property so we could get our land properly surveyed and our parking lot and expanded at a later date.

She said that the next week, she had to be in New York and people were literally making videos and texting them to her. "Look at the parking lot, it's so amazing"! It takes a lot to impress state employees who have worked in government a long time; and trust me, they were all totally wowed! So I just want to thank this Commission, and I would like for Director Patterson and Casey Shell, to step up here, so I can present this picture to your agency from Tourism and Commerce to show you our appreciation and thanks.

Mr. Green explained that the contractor actually defaulted on his work, wouldn't show up to the project. We had had problems with him on a previous project in Division Five. So it went back to the bonding company. The bonding company took bids, which was nearly double what our bids were originally and by agreement we allowed them to pay us the difference between the low bid and what their bid was, which was \$416,235. Our next three bidders after this contractor bid around \$600,000. We feel like this is a win-win situation. The bonding company running projects is generally not a well-run project; they're more difficult to manage, in some degree.

Commission Burrage commented what they did is they let a bid; the guy didn't go to work. The bonding company is going to finish it and they went out and got their own bids that we had nothing to do with; and those bids, they paid us the difference and so we got a check.

Mr. Green said, "That's correct". We hope to let it out through our bidding process and allow our contractors an opportunity to bid.

Commissioner Burrage commented we will give our contractors an opportunity, but we've protected ourselves. That's what we have done, but no new letting has been made yet.

Mr. Green said, "That's correct".

Mr. Burrage asked, "Se we're approving the settlement"?

Mr. Green replied, yes it's the settlement; the termination of the construction contract.

Ms. Hilmes said every year when we prepare the budget, we have an analysis whereby we look at available cash, add in projected revenues, compared to obligations to determine carry over to prepare the budget where we need it (budget), and if we don't, we reserve the funds to use it when we do need it, and this is one of the instances when we do.

Commissioner Love said so you got a set-aside fund that you can pull money from.

Ms. Hilmes stated that it is just literally unbudgeted money.

ITEM TO BE PRESENTED BY LOCAL GOVERNMENT DIVISION ENGINEER - Mr. Sheffert

151. Presentation of the proposed CIRB 5 Year County Work Program

The Department has worked with the County Circuit Engineering Districts from across the State to compile an update to the 5 Year CIRB plan.

Funding for the CIRB program is currently apportioned from revenues accruing from the Motor Vehicle and Registration Act to be used for the construction or reconstruction of county roads or bridges that are of the highest priority.

The Plan was developed with consideration for the critical needs of the County Transportation System within the financial constraints of funding projected to be available to the program.

Item No. 151 was deferred.

ITEM PRESENTED BY THE DIRECTOR - Mr. Patterson

152. Director's Report

Director Patterson stated that on September 17, 2015 Dan Case, who was the head of the Oklahoma Trucking Association, passed away after a year-long battle with pancreatic cancer. Dan was a friend of ODOT, he was always working for better transportation, obviously for the trucking industry, but for all Oklahoma and all of the country. He was one of the largest proponents of the Port of Entry system we are now establishing, because he believed that safe trucking led to safe highway travel and a safer life. He was not one that we always agreed with, Dan and I spent many hours at the counter discussing and debating certain issues, but he was always there for us and we were very saddened to hear of his passing.

Earlier in the commission, in the Consent Docket, you approved 10 railroad crossing safety projects. It is the beginning of the effort that Governor Fallin announced last fall that we would touch more than 300 crossings throughout this state. It's an effort that takes in the help of local entities, county and city, the railroad certainly, because they get to do all the work and ODOT because we get to provide them money; and certainly Operation Lifesaver is a huge advocate of this effort. I mentioned this at a recent AASHTO meeting as one of the highlights that we're doing here in Oklahoma, and my colleagues were astounded that we would actually be in an opportunity to create this kind of safety on our crossings. Nearly 90% of these crossings don't involve the highway system; they involve city streets and county roads. It is something that we have long wanted to do with the increase in rail traffic in the United States. We can do what we can here in Oklahoma, and certainly, we've seen increased rail traffic, but even with the increased rail traffic, there are dangers that come with transporting a crew; we've seen some incidents around the country involving that. So we're just trying to build a little fire to make highway safety, street and county road safety a priority. I know Secretary Ridley wants to make a comment on this, because it was a huge issue for the Governor in her announcement last year.

Secretary Ridley said that Director Patterson and his staff have something very much in common with Governor Fallin, and that's the protection and safety of the people that use our facilities. I know that this is paramount with the Commission, certainly as evidenced by your willingness to approve the funds to be used in this way. Director Patterson was able to, if you recall, to sale a section of rail line, the proceeds of that will be used to fund this great endeavor to improve the safety at our rail crossings. What's unique about this is that the private sector is a cooperative partner in improving these rail crossings and the safety, along with, as Director Patterson made mention, county governments and city governments. So it's a unique opportunity where all of the parties involved are

wanting toward a common goal, but without Director Patterson, his staff and this Commission's approval today, would have not gotten started. The Governor very much appreciates the follow-up to make sure that it happens, because a lot of times, we'll make announcements about things, and sometimes they die on the vine. This agency and this department always follow through with their commitments, and this is an example of that, and I know that if Governor Fallin was here, she would say, "Thank you".

Director Patterson stated that he wanted to make a comment about Item 150. You approved an increase in the budget for asset preservation. Last commission meeting, you received as an informational item our Asset Preservation Plan for the upcoming year. After that approval, we began to think about, was that really enough? Given what has happened to our service on the highways in the last 12 months. Certainly and I've commented about this before, the energy sector and the impact that they've made with the robust energy industry going on in parts of this state, a lot of truck traffic making a significant difference in our service. But we were already behind before that even started; and then to go through the winter and the spring that we did and the huge rains that followed. So we've lost a lot of pavement; so after we reviewed the Asset Preservation Plan last month, we decided that we would seek an increase of \$20 million in that plan, so that's why Chelley brought that item before the Commission today. It's going to be allocated out, just like the rest of the Asset Preservation Plan. It's allocated out to each commission district, but more importantly than money, and like Chelley said it's unbudgeted revenue; it's not unaccounted for, but it is unspoken for. It's a situation that really dates back to 2008 when we began to see a trend with the federal government, where we had extensions and continuing resolutions, and a threat that they would not be able to pay a reimbursement once we sent it to them on a weekly basis, that they would run into this situation. So we began to build up a cash balance, we adjusted our cash management practices. We're making that adjustment in the other direction right now. We're adjusting to hold less cash, because we really believe that the threat of that payment outweighs, by a bit, the threat of not getting reimbursed from the federal government. So we've adjusted our priorities just a little bit. I would like to have totally taken the threat of not receiving reimbursement from the federal government completely off the table and we could have added more money to the project. But at this time, we're going to do \$20 million because we can adjust our cash management practices by a little bit because of that problem.

Director Patterson reminded everyone that the Commission Meeting next month has been moved from November 2nd to November 9, 2015 at 11:00 a.m.

In closing, I would like to announce that today is a big day at ODOT; because we're going to play a soccer game tonight. I'm a softball guy, you know that, but the last two months, I've gotten into this soccer thing. I go out there and I stand and I cheer, and when everybody else claps, I clap. So tonight, after two and a half months of battling on a weekly basis with other state agencies, coming out of the regular season undefeated, winning the semi-finals, we're in the final game against the Department of Health tonight at 6:00. You guys are invited; I know you're too busy; most of you are from out of town. We usually have 30 to 40 people there, and then you look at the opposing team's sidelines, they have nobody. I'd love to have 100 people there tonight just showing these guys our support, and showing the other team that we're ODOT strong. Thank you!

NOTE: Commissioner Burrage commented that when he began his stint on the Commission in 1990 he was surprised to find that railroads were more important than he thought. He said I've watched with interest as the Secretary, when he was the Director and Director Patterson how they've handled that; and it's a great accomplishment to get those lines sold and put back in the private sector. It was a big decision to acquire those lines, but now to take this third step as the Governor and the Department has done, and to be able to put that money back in there, is a great accomplishment by you guys and your staff. That's where it needed to be, and you've done a great job at it. It could have turned out differently over the year, but it didn't, it was a great success!
