Commissioner Burrage thanked everyone for coming and introduced Special Guests: Former Transportation Secretaries, Neal McCaleb and Gary Ridley. We really do appreciate everybody coming and participating in our Commission Meeting. He also introduced T.W. Shannon from Norman, who is the newly appointed Commissioner for District III. Mr. Shannon works in the banking industry and previously served many years in the State Legislature, including as Speaker of the House. As a lawmaker, Shannon chaired the House Transportation Committee and authored landmark transportation funding legislation.

Secretary Gatz said we are honored to have State Representative, Kenton Patzkowsky in attendance today. He had called to our attention some of the concerns that he had with one of the highways out in his district. This is something that we worked with him very carefully on; and engaged some of our personnel to go out and take a look at. I would like for him to come up and say a few words.

Representative Patzkowsky said I'm here to thank and praise the Commission for approving a speed limit increase on sections of US-54 to 70 miles per hour through Texas County in the Oklahoma Panhandle. The road is primarily a 4-lane divided highway and is a major commercial thoroughfare connecting New Mexico, Texas, Oklahoma and Kansas. He said I also want to thank Division Engineer, Ron McDaniel and his staff for helping me get this done.

END OF CONSENT DOCKET

Governor, Kevin Stitt entered the Commission Room at 11:10 a.m.

Chairman Burrage said it's a pleasure to have the Governor with us today. I will recognize Secretary/Director Gatz to introduce the Governor.

Secretary Gatz said, Governor, we really want to welcome you to the Department of Transportation. We so very much appreciate your support for Work Zone Awareness in the State of Oklahoma; and appreciate you coming and taking the time to visit with us, and sign the Proclamation for us this morning. So thank you very much.

Secretary Gatz said some of the things that from a Work Zone Awareness Campaign standpoint that we want to recognize is, in the last 5 years we've had 65 people killed in work zones. And only 4 of those were ODOT employees; Rickie Nichols Jr. in Division III, Jarrell Gray in Division VIII, Jerald Warden in Division VIII

and Gordon Pipkin in Division VII. The real message is that our workers work in an extremely dangerous environment; and they are out there every day in a work zone with traffic traveling through those zones at high speeds. But often times, the folks that are in the most jeopardy and the most danger are the traveling public that are utilizing and traveling through those work zones. We really want to emphasize the need for folks to really pay attention and put away distractions as they travel through those work zones! We have a PSA that we are going to show, that really represents the kickoff to the work zone safety week. We are going to roll that out and announce it today. The PSA really is designed to help us get the message out that you're going to encounter the summertime construction zones, which is our peak period. This year's theme, if you've noticed out in the atrium, lines up with the Game of Thrones movie. We are calling it, "In the Game of Cones. Safety Always Wins", building on that popularity; and we're continuing with our overarching slogan, which is always, "Your Life Matters, Drive Like It". Again, that reflects putting away your distractions and really pay attention, to remind everyday drivers that they're impacted by how they drive, and the level of attention that they pay in work zones. And one of the problems that we have in work zones is simply, folks need to slow down. Just pay attention and observe the posted speed limits and be extra careful when you're traveling through.

We've got some of our field employees here today, representing their co-workers in the Department. And we've got some folks with the Turnpike Authority volunteering to be the faces and voices of our work zone safety campaign. This particular campaign will run April 1st, beginning today, through the 14th. We have 14 days of Work Zone Wednesday messages that have been extremely popular. We'll have a Press Event out here at Interstate 235, at the interchange on April 3rd. We've got a public outreach event where we'll have the throne set up in Woodland Hills Mall in Tulsa. The Sky Dance Bridge on April 8th, over I-40 crosstown is going to be illuminated in orange in honor of ODOT's fallen workers. April 9th, our Work Zone Memorial featuring the 61 medal ribbons in honor of our fallen ODOT workers will be displayed in Lawton. So we've got a pretty full agenda. April 10th will be Orange You Safe Selfie Day on social media. April 12th, public outreach event at Penn Square Mall here in Oklahoma, where again we'll have the throne set up, and various other social media and press events around the state.

Secretary Gatz before we play the public safety message; Governor Stitt would like to recognize his special guest.

Governor Stitt said a lot of us are parents in here; and I've got 6 children. My 2nd grader son, Remington is with us today and he is doing a project for school where he is going to be Governor for the day. So Remington stand up and wave to everybody.

Secretary Gatz thanked Remington for coming today and then played the PSA for everyone.

Governor Stitt said I wanted to be here and thank all of you folks for your service. And Secretary Gatz, I'm so excited to work with you and give you the tools you need to execute your vision for us to be "Top 10" in roads and bridges. As we work to modernize our infrastructure, we're going to have more and more of these work zones. So it's so important that we bring awareness to this; because when I pulled up and saw the memorial out front, of the people that have been killed in our work zones, it just brings it home. We have to bring awareness to this; and as your Governor, I just want to make sure I lend my voice to this important issue, because safety is so important for us.

Governor Stitt then congratulated ODOT on what they have been able to do. He said if you think back to 2004, when we had 1,168 structurally deficient bridges, and now we're down to 132! I want to continue this momentum as we address other critical infrastructure needs like pavement conditions and 2-lane highways as well. "I've made it clear that I believe Oklahoma can be a "Top 10" State in infrastructure, and we are quickly approaching that goal with our highway bridges. We are going to set some aggressive goals through Secretary Gatz to continue to move this Department forward and deliver great services and a great infrastructure for the State of Oklahoma.

"So I'm just excited to be here with you guys, sign the Governor's Proclamation and present it to Secretary Gatz.

Secretary Gatz asked Jerry Hietpas of Action Safety to come up and say a few words about their involvement. We really appreciate everything that you do for transportation in Oklahoma, and also for your help with this extremely important campaign.

Mr. Hietpas thanked the Secretary and said it is a pleasure to be here today and call to mind, not so much as our company, but to the public that we serve and the cause that we serve. Quite a few years ago, I testified before the Senate Committee for transportation and we were able, through that testimony, to institute the double fines in the work zone. And I thought I was doing a good thing; well, my son came along a few years later with "My Daddy Works Here", which was the drawing of a little girl; and through the eyes of a child, she was trying to communicate to the drivers how important it was to slow down so that her daddy could come home safely. And what he said to me is, "Dad, you had a really good idea, but you grabbed 30 inches too low, you grabbed for their wallet instead of for their heart". And so that's what I'm trying to do; what you see out here today is through his work. After "My Daddy Works Here", was followed by the "No Cell Phones" in the work zone and he is the architect, he took a napkin drawing that Terri gave him and turned it into that little display that we have today. We are just hoping that somehow we can reach their minds and their hearts as they're driving through the work zones. Back in my day, all I had to do was wait for the drunks to go by before I could resume my activities in the evening; but unfortunately, today, those folks are distracted by cell phones 24/7, 365, and put all of these folks at risk every day. And so anything that we can do to draw attention to that, I mean, if we have to legislate it, which of course is going to be our last resort, I hope what we can do is get their attention, get their hearts, and get them to change the behaviors so that they can return home safely from work, or from wherever they happen to be, and don't take any of us with them. Now I turn it over to my son, Greg.

Mr. Hietpas said, I think I chose the small straw when I did that. I'm glad we can help guys. I've been on the road since I was 19, I'm 43 and I've seen a lot of nasty stuff out there; and if we can provide a little bit of fun; because people always remember stuff when they can experience fun. You remember your vacation, but you don't remember what you did yesterday. So if we can kind of wrap a little bit of fun into what we do for a living, I think it matters. We are honored that ODOT allowed us to help; it's a big deal and we really appreciate it. Thanks for letting us be a part of it; it matters to our guys and it matters to our customers.

Secretary Gatz said, "Thank you guys for what you do for us".

54. Director's Report

First and foremost, I'd like to take the opportunity to once again to welcome our newest commissioner, Commissioner Shannon. We very much look forward to working with him going forward; but I'd be remiss if I didn't express appreciation, and say thank you, for the previous service of Commissioner Danny Overland. He was certainly a staunch supporter of the Department and we very much appreciate the service that he brought. At the same time, we look forward to, again, a long future with Commissioner Shannon.

So also, I'd like to express to this Commission, how much the Department appreciates your support and your patience as we work through the transition. And as we, again, work through a little bit of a law change and get to the end of making any new appointments that might occur. So we really appreciate your support and your patience while we work through that.

With the beginning of Work Zone Awareness, we talk a lot about fatality accidents that happen in work zones. But one of the things that goes unnoticed; is the close calls that our men and women face every day as they work in these areas. And we have so many close calls out there where we've got folks working within feet of high speed traffic every day. And I'd just like to take the one final opportunity to really encourage the public to slow down in work zones; pay attention to what's going on around you; observe the posted speed limits and put away your distractions anytime you're driving. But especially when you're traveling through a work zone that has variable conditions, and really look out for the folks that are traveling through and those working in the area.

NOTE: Commissioner Huckabay said the PSA video you showed was excellent!

Commissioner Alexander said he would like to thank all of our contractors that work so hard in keeping the work zones safe, for their employees and ODOT workers. We're very proud of the job you guys do, and we appreciate the Contractors very much for participating in all these programs with us too. So thank you very much.

Chairman Burrage said Secretary Gatz mentioned it and now I will also add my comments that ODOT's done a great job in the transition of the 4-5 Governors that I've been involved with. You guys have really done a great job making sure your new Commissioners were informed and involved. I know you'll continue to do that. We want you to continue with our support, whether we're on the Commission or not. Because the winner needs to be the Department, the State with better roads, better maintenance, and money spent more efficiently, with a higher level of safety going on at the same time. You guys have made a backbone that is very strong in a Department that's doing a great job. And I know everybody up here, whether we're sitting here next month or not, we will always be supportive and cheering you on for your great work. It's been an honor to work with each and every one of you; just keep doing it; embrace new ideas and keep this state moving forward into the top 10 status.
