This caused a 13 day delay for the Contractor, who in turn filed a delay claim. ODOT and Cornell then reached a mediated settlement of the delay claim.

51. Director's Report

Secretary Gatz thanked the Commission for their participation in this historical meeting. All the meetings have went well; and next month meeting will probably be done by teleconference also. The one thing that I can assure you that the Department of Transportation will continue to do is provide every possible mechanism to make sure that these meetings are conducted with the highest level of public access that we can possibly make available. It's extremely important during these challenging times, that we do all we can to make sure the public is included in meetings like this. My expectation is that the May meeting will be conducted remotely also, and potentially, the June meeting. So again, I really appreciate your participation and patience this morning. Thus far, the meeting has went exceptionally well, and the subcommittee meetings went exceptionally well.

I'm sure that all of you have heard that a state revenue failure has been declared. I have nothing but confidence that the Governor and the Legislature will come together and put a plan in place that will carry state government through the end of Fiscal 2020 They are in process of doing that as we speak, and again, I've got nothing but confidence that they will be successful.

In addition, I know that the Legislature and the Governor are considering the prospect for budgetary Fiscal 2021. I am equally as confident that they will come up with a plan that will carry government and continue to provide services as the State of Oklahoma begins our recovery process into 2021. I know the Legislature and

the Governor are working extremely hard. We are supporting them by providing whatever information that we can to help with their efforts, and I believe that will be successful.

On the federal front, we've heard a lot of discussion around what is being called, "Phase 4" that very likely could include an infrastructure investment as a component piece of the recovery initiative. We are monitoring those occurrences very carefully; and ODOT is working hard to make sure that we are poised to meet the needs of whatever comes from the Congress and the President. We will continue our efforts to be ready with projects that can be moved quickly, and with a plan for the longer term.

On the federal level, I think we, potentially, will see a long-term Federal Highway Bill that will materialize out of this effort that will provide for multi years of funding. And optimistically, those multi years of funding may come at a higher level than we originally had anticipated. Again, the Department is doing everything that we need to do right now so we are well-positioned in the State of Oklahoma and ready to move forward with whatever needs may arise to try to help in the recovery.

He thanked all the employees of the Oklahoma Department of Transportation, because they have done a tremendous job. I can't thank these folks enough, because they have stepped up and met every challenge, and exceeded our expectations on a daily basis. Whether they are trying to telework from home, and really doing a great job on that front despite some extremely challenging IT and network connectivity problems. Whether you are talking about our field operation folks continuing to do their job while practicing social distancing. They are still making great progress, and for that, I want to tell them how much we really appreciate their efforts and how much we thank them. Also, I want to thank their families; because during times like this we are all challenged and anxious. The Department of Transportation continues to make progress in our efforts to make sure that our transportation infrastructure continues to support the needs of our critical supply chains.

I would also really like to call attention to a group of folks that are out there working and burning their candle at both ends right now, and that's our health care providers. Those folks are taking care of us at a level like we've never seen, and I want to express how much we appreciate that group, and really thank them for their efforts. And our heart goes out to all of the individuals, the businesses, and the families, that are being impacted by this awful virus.

Thanks again for participation in this historic meeting of the Transportation Commission and I I would be happy to answer any questions that you may have.

NOTE: Commissioner Shannon commented I appreciate your report and the way ODOT has handled this in a professional manner. I know these are unprecedented times; might you speak for a moment on ODOT's efforts to kind of limit the spread? What you have done on an employee basis and maybe give a number of employees that are working from home. And are you where you think you need to be, or is that plan being worked?

Secretary Gatz said the plan that the Department has put in place; we have moved approximately 90% of our essential office staff to teleworking. The other sector we have are our Field Operations personnel; and many of those field personnel simply can't go to telework status. We have implemented every social distancing mechanism and innovation; a lot of times it comes straight from those folks to try and make sure that we are keeping each other and the public, safe and healthy. Again, that begins with social distancing; but they are staggering their reporting times and doing everything they can to minimize assembly. As far as doing safety meetings and everything like that, they are making sure that they are social distancing during those times, and trying to accomplish that in every factor and every component of their operation. As you pointed out Commissioner, this is absolutely a day-to-day management strategy; and we are not done. As the health emergency continues to progress, the Department is fully prepared to implement additional measures to make absolutely sure that our workforce remains safe and healthy.

Chairman McKown asked if we knew of anyone in our Organization that has this virus.

Secretary Gatz stated I am not aware of any confirmed illnesses related to COVID-19 in our Department.

Ms. Riddle reported that ODOT had been monitoring the public audio connection; and it was reported that the public audio connection has been maintained throughout the meeting.
