Secretary Gatz said I would like to just give a little bit of a historical perspective on the speed limits. We've had many conversations over the years with the Legislature about speed limits, normally with an eye to potentially increasing those speed limits. With House Bill 1071 a couple of years ago, we had the opportunity to sit down with Representative Pae and start a very productive and worthwhile conversation about how the Department studies and understands what appropriate speed limits are. The outcome of that was an effort to update our speed study, which again, this item that's being presented today is a culmination of that, to create what I would characterize as a benchmarking condition for our interstate system. This speed study will be a living document. It's something that we will go back and address regularly to make sure that we've got a clear understanding of how traffic patterns are acting, and also to consider any developments that may occur because of any change in the speed limit. We've looked at several safety factors, roadway geometry, site distance, accident collision histories, traffic flows, and existing speed patterns; to really take a deep and detailed dive into each one of these locations to make sure that the recommendations is supported by the engineering. Also we have had extensive coordination with the Oklahoma Highway Patrol and Commissioner John Scully on enforcement. I want to emphasize that it's the "Three E's", Engineering, which materializes in the study that Chad and Brian and the people that have worked on it have worked tremendously hard to compile. Education, which starts with the drivers; please observe all posted speeds, buckle your seat belt, put away your distractions, and pay attention while you're driving. Observe that responsibility and make sure that you have a clear understanding of what it takes for the privilege of being a licensed driver. And then Enforcement, we are working very closely with the Highway Patrol to make sure that we focus enforcement efforts to close that gap between that black and white posted speed and what traffic is actually traveling out on the highway system. New speed limit signs are being produced and will be installed over the next few months.

102. Presentation of the proposed CIRB 5 Year County Work Plan (2021-2025)

The Department has worked with the County Circuit Engineering Districts from across the State to compile an update to the 5 Year CIRB plan.
Funding for the CIRB program is currently derived from a portion of the revenues accruing from the Motor Vehicle and Registration Act as authorized in HB 2249.

The Plan was developed with consideration for the critical needs of the County Transportation System within the financial constraints of funding projected to be available to the program.

The CIRB Plan to improve the county road system includes:

- Approximately $\$ 879$ million in improvements
- Replacement or rehabilitation of 313 county bridges
- Replace or restore 151 Structurally Deficient or Functionally Obsolete
- 22 bridges incorporating recycled I-40 Crosstown bridge beams
- Improvements to 585 miles of county roads

I want to present to him a commemorative Route 66 brick which is inscribed with, "The Oklahoma Department of Transportation recognizes Director of Operations Darren Saliba for his 37 years of contributions to the Department. A conscientious and hard-working man, his hallmarks include leading crews through the I-40 Webbers Falls operations as they expedited critical detour maintenance as well as completing a vital Tahlequah highway loop, improving contracting practices, and maximizing field and central office collaboration". Darren I extend the opportunity for you to come to the podium and make any remarks if you choose to.

Mr. Saliba said I want to thank you for those kind words. I don't want to take up too much of people's time. ODOT is a great place to work for 37 years and it's primarily for two reasons: The great group of people who are dedicated professionals; and right behind the people for the organization is our mission statement, where every day they're concentrating on the best interests of the motorists. So between the people and our mission statement, it's been a great place to work and I appreciate you putting up with me all these years, Mr. Gatz, thank you very much!

Mr. Chairman, thank you for the opportunity to recognize Darren's meritorious service to the people of the State of Oklahoma and to this nation. He's had a tremendous role in transportation for us.

I thank you for your approval this morning of the County Improvements for Roads and Bridges plan. Since that plan was created in 2006, I want to tell you that nearly $\$ 2$ billion worth of improvements have been made out on the county road system. This program is really about allowing counties to put together the resources that it takes to tackle major bridge improvement projects and big projects in the counties that they would never be able to put together the resources to do without this program. The Department is proud to lend our support to administering it and we have tremendous things out on the county system because of it.

To give you an update on our Transit 5310 Program, if you will recall that that is a program that the Department has taken over from the Department of Human Services, and it's really geared towards rides for the elderly and individuals with disabilities. We are continuing to put together an administrative plan and program. So we are completing an online survey and we continue to conduct our telephone town hall meetings to get input from the providers, as we shape that program for the Office of Mobility and Public Transit going forward to the future.

You also approved this morning the award of a project on US-270 near Seiling. This US-270 initiative really crosses three division lines, Divisions 4,5 and 6 between I-40 and Woodward. All of the field divisions and the Commissioners deserve our thanks for staying focused on this highway, as it carries a lot of traffic and we
continue to make improvements. This is one of the five remaining segments that are left to be able to complete the widening of this Northwest Passage.

From a transportation modernization initiative, as you recall, the Transportation Cabinet is taking a hard look at our organizational structure between the Aeronautics Commission, the Department of Transportation, and the Turnpike Authority. We have engaged a Consultant called "Guidehouse" to help us with that. Guidehousde has completed their interviews with executive staff and are now moving forward with additional data gathering, that will happen across the course of the next few months and finish up with some visioning and putting together some guiding principles. From that will come recommendations and we will begin to go ahead and transform into change management. I want to emphasize that we expect this study to take approximately a year; so sometime in late spring or early summer of next year, we will wrap this up with some organizational recommendations.

I want to offer an update on COVID-19 and some of the challenges that it continues to present for us in all of State Government, and all of walks of life in Oklahoma. The Department continues to focus on the CDC guidelines; our personnel are doing a tremendous job of taking care of the health and safety of each other. We are continuing to implement teleworking, social distancing, and mask usage where it's appropriate. I can't thank our people enough for the great job that they are doing out there on a daily basis.

Commissioners, I would close just by extending thanks to Representative Pae and Commissioner Scully for their participation in the meeting this morning. They're great partners in transportation and in all things we do, we appreciate their participation. That's all I have for today.

Commissioner Peterson congratulated Darren on his 37 years of fantastic service and wish you all the best in your future years.

Commissioner Alexander said first I want to thank Darren for his service; and said I hope you have a wonderful retirement. Secondly, it's been wonderful to work with the other divisions on the 270 Project; I just want everybody to know how much the people in Woodward appreciate the work everyone has put into this. And lastly I want to thank the winners of the Safety Awards.
